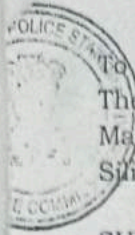

Sir,

I, ASI Nitai Mandal presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted person to the effect that on 04.03.2022 at 22.25hrs onwards acting on source information, myself along with, C/1035 Santosh Rabidas and CV-387 Sukumar Barman had been to Jali busty area and found that the aforesaid person had been selling illegal liquor to the common customers at his shop at Jali busty under Matigara PS. Then I cordoned the place with my accompanied force but taking the advantages of darkness the owner of the shop named Upendar Paswan as well as the common customers who were taking liquor fled away from the spot. On being search of the shop in presence of available witnesses, I found and seized the following seized articles in presence of available witnesses:

1. One plastic jar containing 15 liters of illicitly distilled liquor and marked as Exhibit - A.
2. One bottle containing 600 ml of illicitly distilled liquor extracted from Exhibit - A as sample for examination and marked as Exhibit A-1.
3. One plastic jar containing 15 liters of illicitly distilled liquor and marked as Exhibit - B.
4. One bottle containing 600 ml of illicitly distilled liquor extracted from Exhibit - B as sample for examination and marked as Exhibit B-1.
5. 45 pieces plastic glass.
6. 15 empty plastic bottles.

Subsequently I destroyed the above mentioned Exhibit - A and Exhibit - B in presence of available witnesses whose signature have also been taken in the seizure list. The seizure was made in between 23.25hrs. to 23.45hrs.

Therefore, I pray before your good self that a specific case against the above noted person named Upendar Paswan(85), S/O- Lt. Shibon Paswan of Jalibusty PO- New Chamta, PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
