Sir,

In producing herewith one accused person named Surendar Kujur (23), S/O- Lt. Nandal Kujur of Odlabari, PS Kalimpong, Dist Kalimpong A/P Nischintapur, PO+PS Matigara, Dist Darjeeling under arrest along with following articles under proper seizure.

1] 13 (Thirteen) bottles of Himalayan Gold Country Spirit each bottle containing 600ml. (total 600 ml X 13= 7.8 Ltrs) and marked as "exhibit A".

2] 01 (One) bottle of Himalayan Gold Spirit containing 600 ml, taken out randomly from Exhibit A for examination and marked as Exhibit A-1.

I, SI Newton Biswas of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Surendar Kujur (23), S/O- Lt. Nandal Kujur of Odlabari, PS Kalimpong, Dist Kalimpong A/P Nischintapur, PO+PS Matigara, Dist Darjeeling to the effect that today on 05.03.2022 at 17.25 hrs received a source information that one person named is selling liquor in a shop situated at Patharghata Road under Matigara Police Station without any valid license. Accordingly I informed the matter to the O/C PS and as per his kind direction I along with C/1035 Santosh Rabidas, C/1008 Kanak Roy, and CV-155 Sukumar Das had been to Patharghata Road under Matigara PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing illicit liquor at the shop. Subsequently, I along with my force cordoned the shop and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that the actual owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labeled the above mentioned illegal liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Surendar Kujur (23), S/O- Lt. Nandal Kujur of Odlabari, PS Kalimpong, Dist Kalimpong A/P Nischintapur, PO+PS Matigara, Dist Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19:15 hrs to 19.45 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Surendar Kujur (23), S/O- Lt. Nandal Kujur of Odlabari, PS Kalimpong, Dist Kalimpong A/P Nischintapur, PO+PS Matigara, Dist Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
