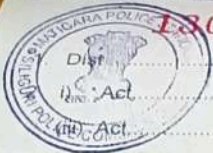

I, PSI Shekhar Adhikary of Matigara Police Station here by lodge a written complainant against the above noted accused persons to the effect that today on 05.03.2022 at 18.35 hrs. onwards while Myself along with other officers and force performing lock down duty around City Centre area under Matigara PS found the above noted accused persons were loitering around City Centre area without wearing mask and also not maintaining social distance violating Govt. Order vide order No.753/XVII-ISS/2M-22/2020, dated-02.01.2022. Accordingly, I warned them to obey the Govt. order regarding COVID-19 but they did not pay heed to my words and strongly opposed my lawful direction. Accordingly, I arrested all of them namely i) Dahim Sarkar (24), ii) Sanjay Barman (28), (iii) Md. Nasib (31), iv) Raja Das (20), (v) Md. Tejul @Bullet (22), (vi) Partha Chowdhury (28) U/S-41 Cr.PC. after observing all formalities

Therefore, I pray before your kind honour that a specific case may kindly started against the accused persons i) Dahim Sarkar (24), S/O- Chanduram Sarkar of Ranaganagar, PO+PS Matigara, Dist Darjeeling ii) Sanjay Barman (28), S/O- Bharat Barman of South Bharat Nagar, PO Deshbandhupara, PS Siliguri, Dist (iii) Md. Nasib (31), S/O- Lt. Md. Nasim Ansari of Darjeeling More, Shibnagar, PO+P.S- Pradhannagr, Dist.- Darjeeling iv) Raja Das (20), S/O- Lt. Sanjay Das of Bhanunagar, PS Bhaktinagar, Dist Jalpaiguri (v) Md. Tejul @Bullet (22) s/o Md. Mansur of Biswas Colony, PO+PS Matigara, Dist Darjeeling (vi) Partha Chowdhury s/o Lt.
