Sir,

I, PSI Newton Biswas of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Santosh Mahato (35) S/O Lt. Pradip Mahato of Bagdogra, Bhujiyapani, P.O+P.S- Matigara, Dist.- Darjeeling A/P Himul, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling under arrest along with following seized articles viz ; 1] 13(thirteen) bottles of Kingfisher Strong premium Beer each bottle containing 650ml, Total 08.45 ltrs., value Rs. 13*130= Rs.1690/- and marked as 'Exhibit -A' and 2] 01 (one) bottle of Kingfisher Strong premium Beer containing 650ml taken from "Exhibit-A" for examination and marked as "Exhibit-A-1" under proper seizure list (which is enclosed herewith) to the effect that on 06.03.2022 at 21.25 hrs. received a secret source information that one person namely Santosh Mahato (35) S/O Lt. Pradip Mahato of Bagdogra, Bhujiyapani, P.O+P.S- Matigara, Dist.- Darjeeling A/P Himul, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling has stored huge quantity of Illegal liquor at his shop without any valid license. Diarized the matter vide Matigara PS GDE No.293 Dt.- 06.03.2022 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with Const- 1035 Santosh Rabi Das, CV- 155 Sukumar Das left for Himul under Matigara P.S to verify the veracity of the source information. On reaching at the spot at 21.45 hrs it was found that huge quantity of illegal Liquor stored in the shop of Santosh Mahato who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the shop. But we apprehend the above noted person namely Santosh Mahato. Thereafter, in the very presence of two available witnesses I search the shop and seized illegal Liquor after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Santosh Mahato. On being asked the said person failed to produce any document for selling and storing of illegal Liquor at the shop. It's a violation under Bengal Excise Act. This seizure was made on 06.03.2022 in between 22.25 hrs to 22.55 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Santosh Mahato (35) S/O Lt. Pradip Mahato of Bagdogra, Bhujiyapani, P.O+P.S- Matigara, Dist.- Darjeeling A/P Himul, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of illegal Liquor at the said shop and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Santosh Mahato (35) S/O Lt. Pradip Mahato of Bagdogra, Bhujiyapani, P.O+P.S- Matigara, Dist.- Darjeeling A/P Himul, P.O- Nemai, P.S- Matigara, Dist.- Darjeeling and arrange for its investigation.
