F.I.R. FOR PHYSICAL ASSAULT

Respected Sir,

I, Arjun Sawaria, son of Mesa Sawaria, R/o. Lala Busty, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, would like to state that today i.e. on 06-03-2022 at about 12.10 P.M. one person namely Raju Mallick, S/o. Unknown, R/o. Defence Colony, Gali No. 8, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, suddenly came to my house and started abusing me with hits and blow. He was using slang language at me and threatened me. After abusing me he snatched money amounting to Rs.3000/- and ran away from my house. Later after sometime Raju Mallick along with his family members namely Rabi Mallick, Rita Mallick, & his mother (name not known) came at my house and started beating me. I was alone and became helpless. Due to their assault I sustained injuries in my eyes, hand, chest & head. On my hue and cry my relatives came and saved me from their cruel hands. He also threatened me with dire consequences. Thereafter my sister took me to Bagdogra PHC, RKS for treatment. Finding no other option I came before you.

It is requested before you in folded hand to kindly take strict necessary action against Raju Mallick, Rabi Mallick, Rita Mallick & mother of Raju Mallick.
