In producing herewith one person namely Ram Narayan Routh (30) @Laxman S/O Lt. Nandu Routh of Ho-Chi- Min- Nagar, Upper Bagdogra Ps. Bagdogra Dist. Darjeeling along with the following articles under seizure viz,

1. 24 (Twenty four) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",

I, SI Binup Mahato of Bagdogra Police Station, SPC do hereby lodged this written complaint against the above noted arrested person namely Ram Narayan Routh (30) @Laxman S/O Lt. Nandu Routh of Ho-Chi- Min- Nagar, Upper Bagdogra Ps. Bagdogra Dist. Darjeeling to the effect that on 06.03.2022 at evening in course of special mobile duty along with force vide Bagdogra PS, GDE no 288 Dtd, 06.03.2022 at around 17.05 hrs and as per secret source information I, along with force held raid at Bagdogra Hathkhola in one shop and apprehended the above noted arrested person who is selling illicit liquors some of his designated customers clandestinely from his shop during the time of pandemic situation in high rate seeing the police party some customers were flee away to run from the shop. On interrogation apprehended Laxman Routh admitted that he is the owner of the shop and run the business since long for his wrongful gain. Subsequently the above noted articles were found on his shop on demand he failed to produce any valid documents/papers or license in support of storing and selling of the said illicit liquor. Accordingly, I seized the above mentioned illicit liquor recovered on his shop under proper seizure list and labelled and also arrested him u/s 41(A) CrPC issuing memo of arrest inform his ground of arrest. The whole process of seizure and labelled was made in between 17.15 hrs to hrs to 18.05 hrs. Total 14.400 ltrs illicit liquors.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Ram Narayan Routh (30) @Laxman S/O Lt. Nandu Routh of Ho-Chi- Min- Nagar, Upper Bagdogra Ps. Bagdogra Dist. Darjeeling and arrange for its investigation.
