SUBJECT:- FIR against **Jagga and Santosh Mahato** of Santoshi Nagar, Near Shyam Mandir, P.O. & P.S. Siliguri, District- Darjeeling for grievous hurt and attempt to murder.

Sir,

I, **SRI RAVIKANT AGARWAL** S/o Late Rawat Mal Agarwal, Business by Occupation, Indian BY Nationality, residing at Santoshi Nagar, Near Shyam Mandir, P.O. & P.S. Siliguri, District- Darjeeling, West Bengal would like to lodge written complaint against the local gundas namely **Jagga and Santosh Mahato** of Santoshi Nagar, Near Shyam Mandir, P.O. & P.S. Siliguri, District- Darjeeling stating as follows:

1. That I am contractor by profession and presently I am in the process of construction of residential building at Santoshi Nagar, Near Shyam Mandir, P.O. & P.S. Siliguri, District- Darjeeling.
2. That yesterday at about 11.30 P.M I was at the said construction site and was accumulating construction materials i.e. cement and sand etc with the help of my staffs and workers.
3. That suddenly the above said miscreants namely **Jagga and Santosh Mahato** along with 5 to 7 other local goons of the area came to our site and stated **abusing me** with bad and filthy languages which cannot be uttered in a civilized society and thereafter they both became furious and assaulted me with fists and blows and also inflicted severe injury on my body with leather belt and other weapons which may lead **my death**.
4. That thereafter they both demanded a sum of Rs.500,000/- as gunda tax otherwise they both along with their men and agents will not allow me to proceed with the construction work of the project.
5. That the above named persons are very dangerous and can go any extent of violence for fulfilling their ill motive.
6. That further they both have threatened me that if I try to lodge any complaint before any police station they will make me face with dire consequences and further they have also threatened that they will not hesitate to kill me and shed blood.
7. That in the hours of terror, I humbly request you to take necessary and immediate action and book my above said miscreants under appropriate provision of law.
