Roshan s/o Not known (2) Son of Md. Roshan alongwith their associates, started abusing my father namely, Pradeep Ghosh S/o Lt. Profulla Chandra Ghosh, who is at his lottery counter at Vivekananda Road (Near Shankar more) and when he and my friends namely (3) Prasenjit Ghosh (34) S/o Sri Pritam Ghosh (4) Somu Ghosh (28) S/o Sri Sadha Ghosh (4) Debasish Ghosh (34) S/o Lt Nitish Ghosh (5) Chandan Ghosh S/o Sri Nikhil Ghosh, all are of Ghosh para, Ward No. 7 SMC, P.O.-Siliguri Bazar, P.S.-Siliguri Distt-Darjeeling, protested, they attacked me with lathi & iron rods and injured me grievously, and I immediately felt down on the ground and said Md. Roshan & his son, name not known, stolen away my Gold chain from my neck.

My friend Debasish Ghosh, shifted me to Siliguri Distt. Hospital and I treated myself here.

Sir, the above named alleged persons namely Md. Roshan, his son & their 25 underman associates, all are resident of Core Depto, Ward No. 7 SMC, P.O.-Siliguri Bazar, P.S.-Siliguri, Distt-Darjeeling are very desperate & dangerous in nature and they have threatened us for dire consequences so, please take necessary action against them.
