Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against 1) Santanu Basu, 2) Saikat Bosu (both are present user), Atul Prasad Sarani, East Vivekananda Pally, Rabindra Sarani, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 08.03.2022 at about 01.30 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Sudipta Moitra, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of 1) Santanu Basu, 2) Saikat Bosu (both are present user), Atul Prasad Sarani, East Vivekananda Pally, Rabindra Sarani, Siliguri, Dist- Darjeeling and inspected service installation, metering installation of Consumer ID 412053390 in the name of Smt. Parbati Bhusan Bose. During inspection it was found that electricity was being used unauthorisedly & illegally by 1) Santanu Basu, 2) Saikat Bosu both are the present user of Consumer Id.- 412053390 by reconnecting the disconnected service line of the metering installation that was disconnected previously on 18.03.2021 due to non-payment of outstanding energy bill amounting to Rs. 22,500.00.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Bentec Electricals & Elec Ltd, serial no.- IPB247315 installed against Con Id. 412053390 seized by preparing a formal seizure list duly signed by representative of Santanu Basu & Saikat Bosu and witnesses. The copy of the seizure list handed over to representative of Santanu Basu & Saikat Bosu and his signature obtained as token of receipt.

As 1) Santanu Basu, 2) Saikat Bosu has committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
