SUB: FIRST INFORMATION REPORT.

Sir,

I, Sri Ajit Kumar Chanda, Son of Late Subal Chanda, presently residing at Netaji Colony, Noulkaghat, District – Jalapaiguri, do hereby lodge this complaint against Smt Babli Sarkar, Sri Prasenjit Saha and Smt Jhunu Das to the effect that I was married to one Babli Sarkar, Daughter of Late Ganesh Sarkar and Jhunu Das on 12th January, 2006 and out of our wedlock two male child have been born namely Angshu Chanda (13 years) and Aadi Chanda (8 years). Since last 7 years I along with my wife and my two child has been residing at rented house at Chinu Bhawan, near Bhutia Market, P.S. Siliguri, District – Darjeeling under the landlord namely Chumki Di. That day before yesterday i.e. on 07.03.2022 I left from our rented house situated at Chinu Bhawan, Bhutia Market at 7.30am in the morning and in the evening around 6.30pm I received a call from said Babli Sarkar that she have got the order of ex-parte divorce from the Ld. District Judge, Jalpaiguri on 24.01.2018 and as such she is not my wife anymore and that she is fleeing away with my two children. I was totally shocked after listening to her over phone call since I was never aware of the divorce between as the same has been obtained by fraudulent means and even after said divorce in the 2018, since last 4 years she has been continuously residing with me as husband and wife and never informed me regarding the said divorce. After the said phone call I rushed to our rented house at Chinu Bhawan, Bhutia Market and I was shocked to find that the entire house was empty and all my belongings including household articles such as one Samsung LED TV, show case, steel bed, two gas cylinders in my name, almirah, gold chain of my child, two pieces of gold chain and one gold ring belonging to me, three pieces of gold kada (churi), gold sakha badhano, two pair of gold ear rings, one gold nose pin, one gold chain and ring all purchased by me for Babli Sarkar believing to be my wife during Durga Puja, 2021 and cash amounting to Rs. 5,30,000/- (Rupees Five Lakhs Thirty Thousand) only out of which Rs. 1,80,000/- (Rupees One Lakh Eighty Thousand) only was obtained as loan from Bandhan Bank, Shaktigarh Branch last month for construction of house at Naukaghat and all the aforesaid articles and cash was kept under custody of Babli Sarkar. The said Babli Sarkar has induced and deceived me by residing with me after getting divorce in the year 2018 and concealing the fact of divorce from me. Babli Sarkar was well aware of the fact of divorce and she was also well aware that I do not know regarding the order of divorce and taking undue advantage with fraudulent means has stayed with me for 4 long years after divorce and when she got hold of huge amount of cash and gold taking the undue advantage of the situation she fled away with all my belongings and cash. I have come to know from neighborhood that the said Babli Sarkar has fled away with one Prasenjit Saha (Ph- 8158084370) of Samsan Para,

Maynaguri in the afternoon of 07.03.2022 along with all the articles and the entire facts is within the knowledge of her mother Jhunu Das, Resident of Fulbari, Batellion more right side. Thereafter, I rushed to her mother Jhunu Das at Fulbari at around 8.30pm of 07.03.2022 and I was totally shocked to find that all my household articles including table, chair, show case, almirah, steel bed was kept in her house and when I asked about the whereabouts of Babli Sarkar and my two child she started abusing me in filthy languages and threatened me of dire consequences. The said Babli Sarkar in conspiracy with Prasenjit Saha and Jhunu Das has conducted themselves in such a manner so as to intentionally deceive me with false promises and assurances and have stolen all my household articles, gold articles and hard earned cash amounting to Rs. 5.30 lakhs approx. The mobile number of Babli Sarkar (9339230970) is switched off since evening of 07.09.2022 and now I lost all the hope of getting my hard earned gold articles and money back.

Thus clear **mens rea** of defrauding, cheating, stealing and misappropriating the goods/ money gets established from the aforementioned acts of the accused persons. Thus it is evident that the accused persons have committed offences under sections 406, 420, 379 and 120B and other appropriate sections of the Indian Penal Code.

That I have been totally broken and my health condition has severely deteriorated after being duped and cheated by said Babli Sarkar, Prasenjit Saha and Jhunu Das.

Hence, it is humbly requested to initiate investigation against the aforesaid accused person under relevant provisions of law for the ends of justice.
