In producing herewith three arrested accused persons namely (1) Krishna Biswas (43), S/O- Late Dhanjay Biswas of Batashi, PS- Khoribari, Dist- Darjeeling, (2) Diksha Tamang (19), D/O- Bishal Tamang of Champasari Anchal, PO- Champasari, PS- Pradhannagar, Dist- Darjeeling and (3) Salima Sawriya (22), W/O- Jahiruddin Sk of Fubari Patan T.E., PS- Matigara, Dist- Darjeeling along with following seized articles :

- (i) One half used Bottle of 100 ml. Johnson's Baby Oil,
- (ii) One VIVO Mobile Phone having IMEI No- 868409040348504 and 868409040348496 of accused Krishna Biswas,
- (iii) One Samsung Mobile Phone having IMEI No- 358818744106215/01 and 359210304106216/01 of accused Krishna Biswas,
- (iv) One Union of India Driving Licence having No- WB73 2004 0358344 in the name of Krishna Biswas valid upto 30.09.2029.
- (v) Five number of 'MOODS' Condom.

I, Manish Kumar Yadav, Assistant Commissioner of Police, West Zone, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted 03 (three) arrested accused persons namely Krishna Biswas, Diksha Tamang and Salima Sawriya to the effect that on 09.03.2022 at 14:30 hrs received a specific secret information that some prostitution business is going on at "Thairapy Unisex Salon" at City Centre under Matigara PS Dist- Darjeeling under the coverage of body massage. Accordingly, I along with force left for "Thairapy Unisex Salon" at City Centre under Matigara PS via Matigara P.S and obtained assistance of the police team from Matigara PS to verify the veracity of information. This refers to Matigara PS GDE No. 428 Dated. 09.03.2022. SI Abhishek Theengh, SI Newton Biswas, C/ 1008 Kanak Roy, C/1035 Santosh Rabidas, LC/1251 Yankila Bhutia, LC/1324 Lalita Singha all of Matigara PS, SPC and SI Rash Bihari Saha, C/121 Satrughna Sen all of SOG, SPC accompanied us.

On arrival at "Thairapy Unisex Salon" at City Centre, under Matigara PS, I called two available local independent witnesses namely 1) Kiran Baraik, S/O- Surjan Baraik of Atal Tea Estate, Paka Line PS- Naxalbari, Dist- Darjeeling and 2) Parimal Barman, S/O- Arabinda Barman of Patharghata, Helapakhrijote, PO- New Chumta, PS- Matigara, Dist- Darjeeling and requested them to remain present during the time of raid, search and seizure, if any. Subsequently, we entered into the shop styled as "Thairapy Unisex Salon" at City Centre ground floor along with the aforesaid witnesses, we found one female person at reception counter who being asked, disclosed her identity as Salima Sawriya (22), W/O- Jahiruddin Sk of Fubari Patan T.E., PS- Matigara, Dist- Darjeeling. We disclosed our identity and explained purpose of our presence at the salon. In presence of witnesses, we search the said "Thairapy Unisex Salon". We found one small room made for customers for sexual act and the said room of the salon was under lock from the inside. Then we knocked the door of the room and when opened, we found one male and one female person inside the room in an objectionable position and male was naked and was wearing only half -pant, they were involved in sexual activities. Thereafter with the help of lady police we separated the female from the male person. On being asked by me the female person disclosed her identity as Diksha Tamang (19), D/O- Bishal Tamang of Champasari Anchal, PO- Champasari, PS- Pradhannagar, Dist- Darjeeling and further she disclosed that that she along with Salima Sawriya and Paru Pradhan and others are operating this illegal business of prostitution.

On interrogation said male person disclosed his identity as Krishna Biswas (43), S/O- Late Dhanjay Biswas of Batashi, PS- Khoribari, Dist- Darjeeling and he admitted that he came there for his sexual pleasure in lieu of paying money. He further disclosed that today he was informed at the reception of the salon that they give sexual pleasure for money and as he agreed to pay money, he was taken inside the room behind the counter, thereafter he and Diksha Tamang got engaged in sexual activities.

On further interrogation both the detained lady namely Diksha Tamang and Salima Sawriya stated that they in connivance with Paru Pradhan and others are operating this business of illegal prostitution under the camouflage of body massage in a public place i.e. City Centre, Matigara for their wrongful monetary benefit. They also admitted that they meet up the urges for sexual pleasure of customers by demanding extra money and provide them sexual pleasure.

In course of further interrogation it is revealed that the detained lady namely Diksha Tamang and Salima are co-conspirer along with Paru Pradhan and others in inducing persons to carry on prostitution under the veneer of ostensible lawful business activities.


Accordingly, we searched the "Thairapy Unisex Salon" in presence of independent witnesses and found above noted articles and seized under proper seizure list as noted above. Then, I arrested the above noted accused persons namely Krishna Biswas, Diksha Tamang and Salima Sawriya and subsequently, I brought them to Matigara Police Station.


