Respected Sir,

With due respect, **I, SRI PRADIP ROY**, Son of Late Ranjit Roy, Resident of Atharakhai, Shiv Mandir, Indira Pally, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling, would like to lodge this Written Complaint before your good office to the effect that Smt. Aloka Roy (Paul) (Since Deceased) was my legally married wife and out of lawful wedlock, one male child and one female child were born and their names are Sri Abhijit Roy @ Babai and Smt. Priyanka @ Puja Roy and my wife Smt. Aloka Roy (Paul) died intestate on 10.01.2012 at North Bengal Medical College & Hospital, leaving myself and my son and daughter. Sir, my son Abhijit Roy @ Babai is a habitual drunker and he is engaged himself in so many illegal activities and he used to consume several narcotic drugs and contraband substances and as and when I used to make protest against him, he did not bother to assault me and to that effect, I have lodged complaint before the Commissioner of Police, Siliguri Police Commissionerate. Thereafter, my said son **ABHIJIT ROY @ BABAI** (having Phone No. 90025-97610) married with one **SMT. RAKHI ROY (SARKAR)** (having Phone No. 81161-12454 & 81164-67259) in the year of 2010 and immediately after his marriage, my son and his wife left our house and started to reside separately at his in laws house at C/O - Ananta Sarkar, Panda Para, Kalibari, Bowbazar, Deshbandhu Nagar, 5 No. Gali, P.O. Bowbazar, P.S. Kotwali, Dist. Jalpaiguri. Thereafter, my daughter also married with one Sri Pintu Mandal in the year of 2014 and after her marriage, she went to her matrimonial house and started to reside there with her husband and in laws members and since then, I have been residing at the aforesaid address alone and used to maintain myself somehow. Sir, in order to maintain my daily livelihood, I have purchased a second hand four wheeler Bolero Pick Up vehicle bearing Registration No. **WB-73D-4822, Model - 2015** and I have purchased the said vehicle from Md. Shahabul Akhtar in the year of February, 2021 with financial assistance of the HDB Financial Services Ltd. and after purchasing the said vehicle, I have been paying the monthly installments @ Rs.11,200/-only per month with respect to the said vehicle to the finance authority and still now, several EMIs are due and payable by me and I had been plying the said vehicle on commercial purpose and the said vehicle is my only source of earning. Sir, after purchasing the said vehicle, I had been using the said vehicle on hire basis. Immediately after

purchasing the said vehicle, my said son and his wife came to my house and requested and induced me to allow them to reside in my house as he has left his earlier acts and activities and also induced me to allow him to ply my said vehicle on commercial purpose and also assured me that he shall pay the remaining EMIs amount to the financial authority time to time and on being induced by them and considering their said assurance and taking the relation of father and son, I allowed him to stay in my house and also handed over my said vehicle in his favour to ply the same on hire basis. Thereafter, he has started to ply my said vehicle and also paid the monthly EMIs only for two months and after paying the two months EMIs, he has stopped to pay the EMIs to the financial authority and inspite of my several request, he did not pay further installment amount to the financial authority and thereafter, when I asked him about the whereabouts of my said vehicle, he started to neglect me and also assured me that my vehicle is in safe condition and lying in his custody and believing his said version, I did not make any protest against him. Thereafter on several occasion, I asked him to handover my said vehicle in my favour as he has failed to pay any amount towards the EMIs out of the earning from my said vehicle and due to that reason, I have been facing tremendous financial crisis and for which, I have failed to pay the EMIs amount to the financial authority also and when I asked and requested my said son to return back said vehicle, he refused to return back the same in my favour and also threatened me with dire consequences. Thereafter, I came to learn that my said son has handed over my said vehicle to one **BISWAJIT BARMAN @ CHIKA** (having Phone No. 73187-26187) of Gossainpur, Bagdogra, Dist. Darjeeling without my consent and after knowing the said facts when I asked him to return back my said vehicle in my favour, my son has started to threaten me with dire consequences and also told that he will not return back my said vehicle in my favour and he also did not bother to give any information about my said vehicle and thereafter, he along with his wife again left my house and started to reside at his in laws house. Thereafter, on several occasion, I asked and requested my son and his wife to return back my said vehicle but my son did not pay any heed to my request and on contrary, he has threatened me with dire consequences and also told that if I again make any protest against him, he will not hesitate to destroy my said vehicle and my life also. Sir, on 03.01.2022, I again contacted with my son over phone but he refused to receive my phone calls and thereafter, said Biswajit Barman picked up my phone call and when I asked him to pay the monthly EMIs amount, he started to threaten me with dire consequences and also told me that he has already sold out my said vehicle to a third person after taking a huge consideration amount against my said vehicle and also threatened me by saying

that until and unless, I will give him the said amount, he will not return back my said vehicle and when I raised my voice against him, my son threatened me by saying that he will kill me if I again asked him to return back my said vehicle and nobody will do anything against him as he has good nexus with the anti-social persons. Sir, considering the relation of father and son, I have handed over my said vehicle in his favour for plying the said vehicle on hire basis only but thereafter, I, realized that taking advantage of our relationship, my son in conspiracy with his wife induced me to handover my said vehicle on some false plea and thereafter, handed over my said vehicle to any third person after receiving huge amount without my consent and it is my firm belief that my son Abhijit Roy @ Babai in conspiracy with his wife Smt. Rakhi Roy Sarkar and one Biswajit Barman @ Chika have stolen my said vehicle in fraudulent and preplanned manner for their wrongful and illegal gain and thereby, cheated and deceived me intentionally.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal action against the aforesaid persons as per the provision of law and also recover my said vehicle from their custody and obliged thereby.
