In producing herewith one arrested accused person namely (1) Swapan Banik (29 yrs), S/O Sri Ganesh Banik of Sarada Pally Rabindra Sarani W/no. 37 PS Bhaktinager Dist. Jalpaiguri in custody and the following articles under seizure from the possession of the above noted accused person ----

1. One (01) cartons of "WISCOF" Codeine Phosphate & Tripolidine Hydrochloride Syrup, Cough Syrup, containing 200 (Two hundred) bottles, each bottle containing 100 ML, Manufactured & Marketed in India by WINDLAS BIOTECH PRIVATE LIMITED Batch, NO-WWI21083 MFD-SEP/2021, EXP DT. AUG/2023, MRP Rs.199.79 marked as exhibit "A-1". One bottle taken from exhibit "A-1" as sample marked as exhibit "S-1".

I S. I. Swapan Kr Ghosh of Ashighar OP P. S. Bhaktinager do here by lodge this complaint against the above noted accused person to the effect that today on 11.03.2022 at 14.15 hrs. received a secret source information from my source that one person namely Swapan Banik of Sarada Pally Rabindra Sarani stored a huge quantity of restricted Narcotics drugs inside the Garage of his house at Sarada Pally Rabindra Sarani without any valid papers with a view to sell the drug to local drug peddlers at Siliguri and surroundings area. Accordingly, I diarised the matter vide Ashighar OP G.D.E. No.259 dated -11.03.2022 and informed the matter to O/C, Ashighar OP and as per his kind instruction myself along with A.S.I. Krishna Ch Singha and C/729 Dinesh Ch Roy, C/877 Munna Ahmed CV/909 Nitya Nanda Choudhury all are of Ashighar OP left for Sarada Pally Rabindra Sarani at 14.25 hrs. to verify the veracity of the information vide Ashighar OP G. D. E. No.260 Dated - 11.03.2022. On way to Sarada Pally Rabindra Sarani, I called two independent witnesses namely [1] Ajay Sarkar (31) S/O Swapan Sarkar of Niranjan Nagar Ghogomali PS Bhaktinager Dist. Jalpaiguri and [2] Sujit Roy (30) S/O Satish Roy of Telipara, Naresh More PO Ghugumali PS Bhaktinager Dist Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 14.45 hrs. myself along with my accompanying party arrived at Sarada Pally Rabindra Sarani and as indicated by my source. At 14.55 hrs. myself along with my accompanying party surrounded the house of above noted accused person. On being asked he disclosed his identify as noted above. On being further asked he stated that he has stored huge quantity of restricted Narcotics drug at his Garage. After disclosing our identity I asked him whether he has any objection if search is conducted in his Garage in presence of any Executive Magistrate or Gazetted officer and he agreed to be searched in presence of any Gazetted Officer. I served him a notice in accordance with the provisions of law in this regard. Then at 15.05 hrs. of 11.03.2022 I apprised Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and requested him to remain present at the spot as Gazetted Officer. At 15.35 hrs. Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC arrived at the spot. I disclosed the identity of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC to the accused person as Gazetted Officer. Under supervision of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC and the above noted witnesses the Garage was searched keeping strict regard & decency and recovered the above articles from the Garage of above noted accused person. He further confessed in presence of Gazetted Officer and other witnesses that he procured the restricted Narcotics drug from Kolkata clandestinely for the purpose of selling it to the drug peddlers of Siliguri and surroundings area with a view to earn huge money quickly. On interrogation he disclosed that he had been dealing in such business for last few years importing it from Kolkata and selling the same to the drug peddlers of Siliguri and surroundings area. On being asked he failed to produce any documents or license in support of his possession of such restricted Narcotics drug.

Then as per direction of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC I counted and found One (01) cartons of "WISCOF" Codeine Phosphate & Tripolidine Hydrochloride Syrup, Cough Syrup, containing 200(Two hundred) bottles, each bottle containing 100 ML, Manufactured & Marketed in India by WINDLAS BIOTECH PRIVATE LIMITED B.NO-WWI21083 MFD-SEP/2021,EXP DT.AUG/2023,MRP Rs.199.79 marked as exhibit "A-1". one bottle taken from exhibit "A-1" as sample marked as exhibit "S-1" and seized the above noted recovered articles as Alamats under proper seizure list under the supervision Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC duly signed by the local witnesses and the accused person. The seizure was made in between 16.35 hrs and 17.05 hrs. Then, I arrested the above noted accused person after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest duly signed by the accused person and witnesses. Thus, the accused person violated the terms and conditions of N. D. P. S Act. for possessing such restricted Narcotics drug without any legal authority.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely (1) Swapan Banik (29 yrs), S/O Sri Ganesh Banik of Sarada Pally Rabindra Sarani W/no. 37 PS Bhaktinager Dist. Jalpaiguri and arrange for its investigation.
