Respected Sir / Madam,

I, Puja Deb Das , W/o. Sri Hiplal Das , R/o. Adarsha Nagar Colony, Ward No.04, P.O. and P.S. Siliguri, Dist. Darjeeling would like to inform you that on 29/02/2013 one Hindu Marriage was solemnized between me and a person namely Sri Hiplal Das, S/o. Late Shankar Das, R/o. Adarsha Nagar Colony, Behind the Madrasha, Ward No.04, P.O. and P.S. Siliguri, Dist. Darjeeling as per Hindu Rites and customs at Adarsha Nagar Kali Mandir and during that time my as well as his family members also presence and at the time of marriage as per demand of my husband my parents also gave him a sum of Rs.30,000/- (Rupees Thirty Thousand) Only by cash and also gave one Gold Neckless, Two pair of ear rings, one finger ring etc and also gave others house hold articles such as Khat, Desintable, Alna etc and after the aforesaid marriage I went to my matrimonial house and started there with my husband as a husband and wife and it is also important to mention here that out of the said wedlock one female child also born on 29/03/2014 namely Nandini Das.

It is important mention here that after few months of my marriage I noticed that my above named husband came to home at late night with drunked condition and after coming to home he always started to abused me by using filthy languages and also tortured me by way of physically and mentally but I tolarate the same because at that time I was pregnant and I taught that he will change after born of my baby but nothing will be changed after born my baby and it is also important to mention here that after born of my aforesaid female child he neglected to provide proper food or cloths to me and my aforesaid female child but I tolarate all those in-human torture of my husband with a hope in my mind that one day he will change but such day never come to my life.

It is pertinent to mention here that during that time he also demanded money from me and gave me pressured to bring a sum of Rs.50,000/- (Rupess Fifty Thousand) Only from my parents but when I told him that my parents are very poor and they are / were unable to pay the same at that time he became more ferociuas and started to assaulted me with fist and blows and it is also important to mention here that several times he thrown me out of my matrimo-

nial house at late night and during that time I took shelter at my parents house but each and every time I came back at my matrimonial house after family meeting and also after taught the better future of my aforesaid female child but ultimately on 10/02/2022 at about 01.00 A.M. when I was sleeping at that time my husband suddenly with help of pillow he pressed my mouth and for that reason I could not take breath properly and he tried to kill me by the aforesaid way and ultimately with the marcy of god some how I save myself from his hand and out of fear some how I along with my aforesaid female child managed to escaped from there and took shelter at my parental house and after went to my parental house he till now over phone as well as on road always threatened me with dire consequences and told me that he will thrown acid on my face for that reasons I spend my days right now very bad condition and it is also important to mention here that on 02/03/22 at about 03.00 A.M. he came in front of my parental house and started to used filthy languages in respect of me and my mother and after listening the same when I along with my mother tried to protested the same at that time he assaulted me with fist and blows and also threatened me with dire consequences so, right now I spend my days with in fear So, no other alternative way today with help of my well wishers I lodged this Written Complaint before you against the above noted person.

Therefore I request you please take necessary legal action against the above noted person and also save me from his hand as early as possible..


