I, The unregistered would like to draw your kind attention towards the fact that on 01.02.2022 at round 12:15 pm when I was in my shop namely Shree Ganpati Décor situated at 1st floor Durga Tower, Burdwan Road, Police Station: Siliguri, District : Darjeeling , four unidentified people wearing mask forcefully entered into my shop and started demanding sum of Rs. 5,00,000.
