Sir,

With due respect I Sri Pawan Kumar Agarwal, S/o Late Mahabir Prasad Agarwal, resident of Khalpara, Agreasen Road, Ward No - IX, P.O & P.S - Siliguri, District - Darjeeling would like to inform you that on 1 - 1 - 2022 one Sawarmal Sharma, Shiv Lal Moth and Kapil Sharma & Others came to my shop named as Arogya Niketan Medical Stores, Khalpara and have disclosed that they are the distributor of medicine and came from Guawahti to supply medicine and to take orders for medicines and have induced me to pay a sum of Rs. 7,00,000/- with assurance to supply the medicine within 4 days and as I am a businessman by profession, I have believed their version and have paid a sum of Rs. 7,00,000/-. After making payment of the said money, I have started waiting for the ordered medicines but I have not get the medicines and whenever I tried to know their whereabouts, over phone, they have started avoiding for this and that reason. On 27 - 2 - 2022 I have again asked them either to return my money or supply the medicine as per my order, but they have neither give me satisfactory reply nor they have committed to return my money or supply medicines rather they have assured me that very soon they will come to Siliguri and meet with me.

Yesterday i.e. 9 - 3 - 2022, I have again made contact with the above named persons, but they have flatly denied to supply medicine and flatly denied to return my money and threatened me to forget the money and medicines.

Sir, the above named persons have falsely induced me to pay them a sum of Rs. 7,00,000/- on the false assurance of supply of medicine and now they have denying to return my money or supply medicine against the said money which they have received from me.

So, requesting you to investigate the matter and take necessary legal action against the above named persons for the interest of justice.
