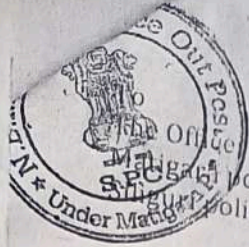

In producing herewith arrested accused person named Dhiren Roy, S/O Lt. Naren Roy of Kawakhali Bazar, P.O-Sushruta Nagar, P.S- Matigara, Dist.-Darjeeling along with copy of memo of arrest, seizure list and seized articles viz 26 (Twenty six) Sealed Himalayan Gold Bottles 60Up Country Spirit each containing 600 MI Rs. 120/- each totaling amount of Rs. 3120/- marked as exhibit "A" and one bottle taken as sample.

The fact of the case is that today on 12.03.2022 at 18:05 hrs received source information that one Dhiren Roy, S/O Lt. Naren Roy of Kawakhali Bazar, P.O-Sushruta Nagar, P.S- Matigara, Dist.-Darjeeling have stored huge quantity of I.D liquor at his house illegally for sale to the People for his wrongful gain.

I informed the matter to O/C NBMC OP and as per his direction I along ASI Anupan Roy, C/340 Pranab Adhikary, C/ 772 Bipul Sarkar, C.V-158 Partha Sarkar left for Kawakhali to work out the information. At about 19:25 hrs held raid at the house of Dhiren Roy, S/O Lt. Naren Roy of Kawakhali Bazar, P.O-Sushruta Nagar, P.S- Matigara, Dist.-Darjeeling and on search 26 (Twenty six) Sealed Himalayan Gold Bottles 60Up Country Spirit each containing 600 MI Rs. 120/- each totaling amount of Rs. 3120/- have been recovered. On demand he could not produce any documents / License for his possession such quantity of I.D liquor. On interrogation he confessed that he stored the said I.D liquor illegally for sale to the interested persons for his wrongful gain.

So, I seized the said 26 (Twenty six) Sealed Himalayan Gold Bottles 60Up Country Spirit each containing 600 MI Rs. 120/- each totaling amount of Rs. 3120/- in presence of witnesses under proper seizure memo and arrested him U/S 41 Cr.P.C.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Dhiren Roy, S/O Lt. Naren Roy of Kawakhali Bazar, P.O-Sushruta Nagar, P.S- Matigara, Dist.-Darjeeling and kindly arranged for its investigation.
