Subject: FIR

Sir,

In producing herewith six (06) arrested accused persons namely (i) Md. Alim (24), S/O- Md. Gafur of Biswas Colony, PO+PS Matigara, Dist Darjeeling (ii) Krishna Roy (19) s/o Lt. Dinesh Roy of Dagapur, Kathaldangi Line, PS Pradhannagar, Dist Darjeeling (iii) Nitish Singh (27), S/O- Shnakar Singh of Prakash Nagar, PS- Bhaktinagar, Dist- Jalpaiguri (iv) Biswanath Saha (19), S/O - Gopal Saha of Dagapur, Bandrijote, PS Pradhannagar, Dist Darjeeling (v) Ganesh Rishidev (32) s/o Lt. Laldeb Rishidev of Darjeeling More, Shib Nagar Colony, PO+PS Pradhannagar, Dist Darjeeling (vi) Bidhan Das (28) s/o Lt. Biren Das of Baghajatin Colony, PO+PS Pradhannagar, Dist Darjeeling (not verified) arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 33 inch (approx) including butt from the possession of Md. Alim which was kept concealed on his back side.
- (2) One iron made sword measuring 20 inch (approx) including wooden butt from the possession of Krishna Roy which was kept concealed on his back side.
- (3) One iron made sword measuring 22 inch (approx) including wooden butt from the possession of Nitish Singh which was kept concealed on his back side.
- (4) One iron made 'Kukri' measuring 12 inch (approx) from the possession of Biswanath Saha which was kept on his right hand,
- (5) One Iron rod measuring 40 inch (approx) in length from the possession of Ganesh Rishidev which was kept on his right hand,
- (6) One iron made 'Dah' measuring 17 inches (approx) including wooden butt which was kept concealed on the back side Bidhan Das.
- (7) Two long iron rods measuring 26 inch (approx) and 30 inch (approx) in length found from the place of occurrence.

I, PSI Newton Biswas, S/O- Nirmal Biswas of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Md. Alim, ii) Krishna Roy, iii) Nitish Singh, iv) Biswanath Saha, v) Ganesh Rishidev and vi) Bidhan Das and others to the effect that today on 13.03.2022 at 00.25 hrs received a sources information that 10/12 youths have assembled at Kabarsthan near Matigara Dry Fish Market which has been lying abandoned under Matigara PS with a view to commit dacoity in a house at Dry Fish Market area. The fact was diarized in GD vide Matigara PS GDE No-880, dated 13.03.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI- Tapan Das, C/986 Rajib Sarkar C/1008 Kanak Roy, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information. At about 00.45 hrs after reaching near Kabarsthan, Matigara Dry Fish Market under PS- Matigara. I met my source and being pointed by the source we started walking towards Kabarsthan and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on a hot chase we managed to apprehend above noted six (06) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Matigara Dry Fish Market area.


I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.05 hrs to 01.35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Matigara Dry Fish Market area. It is also revealed from them that Kalu Seikh, Md. Firoz, and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Md. Alim (24), S/O- Md. Gafur of Biswas Colony, PO+PS Matigara, Dist Darjeeling (ii) Krishna Roy (19) s/o Lt. Dinesh Roy of Dagapur, Kathaldangi Line, PS Pradhannagar, Dist Darjeeling (iii) Nitish Singh (27), S/O- Shnakar Singh of Prakash Nagar, PS- Bhaktinagar, Dist- Jalpaiguri (iv) Biswanath Saha (19), S/O - Gopal Saha of Dagapur, Bandrijote, PS Pradhannagar, Dist Darjeeling (v) Ganesh Rishidev (32) s/o Lt. Laldeb Rishidev of Dareeling More, Shib Nagar Colony, PO+PS Pradhannagar, Dist Darjeeling (vi) Bidhan Das (28) s/o Lt. Biren Das of Baghajatin Colony, PO+PS Pradhannagar, Dist Darjeeling (not verified) (vii) Kalu Seikh, (viii) Md. Firoz and others and others and arrange for its investigation.


