
- i) 112(One hundred and Twelve) pouch of Officer's Choice Whisky, each pouch contains 180ml.
- ii) One maroon Colour trolley bag of company "Macho".

I PSI Sumit Sarkar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 06.03.2022 in course Special drive duty at PS area, I received an information that one person is possessing and transporting liquor illegally from Siliguri Junction under Pradhannagar PS. Accordingly, I share the information to you and as per your kind instruction myself along with ,ASI Ashit Singha CV/128 Ajay Kumar Sahani, CV/992 Jagadish Biswas left PS vide Pradhan Nagar PS GDE No-312 dated 06.03.2022 and rush to the spot and as pointed by the source we held raid at Siliguri Junction and found that one person standing with a trolley bag at Siliguri Junction and apprehended the above noted person and on scarce of his trolley bag we recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is transporting the same to Bihar for selling the same at high rate illegally without obtaining valid document for his illegal gain. Accordingly, I seized & prepared label the above noted articles under proper seizure list. Seizure was made in between 16:05 hrs to 16:45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person Ashish Ranjan Singh(30) S/o Sunik kumar Singh of Bishunpur, PO Kanhauli, PS Mahua Dist Vaishali, Bihar and arrange for its investigation.
