I am a house wife in joint family Ond one oned and its not possible for me to do all of the household chores without a maid all alone whereas there is no help at home at my matrimonial house from any family members of my husband and I used to request my mother in law Smt Golapi Barman to allow me live in a way that make me earn healthily but my mother in law in conspiracy with my father in law Sri Santosh Barman and my husbands brother Ratan Barman, relative of father in law Sri Deben Barman & Smt. Saiba Barman made my life miserable and putting me in pressure day in, day out. I thought that with passage of time the bitterness of my in laws will reduce towards me but it aggravated with time, when the baby child was in my womb my mother in law pressurized me to wash clothes and cook day and night and did not

one girl child was born namely "Manobi Barman " at Siliguri Hospital, after my consciousness came after the caesarian section my mother in law told me that "ami jani tor dara chele baccha jonnmo dewa hobena" my father in law told me that "suorer baccha kono kajer na" and my sister in law used to laugh at me when my in laws used to taunt me, amongst all odds I used to control and bear the torture with a hope of happy marital life. That on 06th March 2022 at about 01:00 P.M. I had a quarrel with my husband and all of a sudden my in laws, i.e. my father in law Sri Santosh Barman, Mother in Law Smt Golapi Barman, my husband brother namely Sri Ratan Barman, relative of father in law Sri Deben Barman & Smt.Saiba Barman, came to our room and started using slang languages towards me, when I objected to it my father in law kicked in my abdomen where I was operated during pregnancy, I was suffering from tremendous pain at that relevant night all of my in laws and husband assaulted me. Since then I have been residing at Pokhaijote, Champasari, P.S. Pradhanagar Dist. Darjeeling. I went to my matrimonial house to bring my gold ornaments but when I went there I found that all my gold jewelleries which is streedhan is taken by mother in law, also the amount of dowry which took from my family as well amount of 1 (One) lakh rupees cash.

I therefore request your good office to look into the matter and take necessary action against the miscreants for torturing me physically and mentally, assaulting me in my abdomen and for stealing my gold jewelries and Cash.
