Sir,

In producing herewith one arrested accused person namely **Bikram Tamang (23) S/o Thendup Tamang of Namchi Bazar, Gantak road, P.S-Namchi, Dist. East Sikkim, Sikkim** and the following property under seizure along with seizure list: -

1. One black colour plastic carry bag containing 1250 (One thousand two hundred fifty) pieces of Winspasmo Forth capsules among which 1010 pieces in loose and 30 (Thirty) Strip of capsules, each strip contains 08 pieces Capsule of Winspasmo Forth capsules containing Tramadol HCl, Acetaminophen & Dicyclomine HCL Capsules (each capsule contains 50 mg of Tramadol Hydrochloride IP), marked as Exhibit "A"
2. 10 pieces loose of Winspasmo Forth, Winspasmo Forth capsules, randomly taken from exhibit "A" for examination and marked as exhibit- A-1,
3. 01 (One) Strip of Winspasmo Forth capsules, Tramadol HCl, Acetaminophen & Dicyclomine HCL Capsules, each capsule contains Tramadol Hydrochloride IP 50 mg, randomly taken from exhibit "A" for examination and marked as exhibit- "A-2",

I, ASI Mir Saide Alam, of Pradhan Nagar PS Siliguri Police Commissionerate do hereby submit this written complaint against above noted accused person to the effect that on 13.03.2022 at 14.25 hrs, I received a reliable source information that one person is standing near S.N.T bus stand, Siliguri Junction under Pradhannagar PS with huge consignment of contraband Capsules for supplying the same illegally to adjacent area.

The matter has been diarized vide Pradhan Nagar PS, GDE No. 719 Dt- 13.03.2022 at 14.25 hrs and I informed you and as per your direction myself along with force all of Pradhan Nagar PS left for SNT Bus Stand by Govt. vehicle bearing no- **WB-74AC-9851** to verify the veracity of the information accompanied by my source.

At the time of departure from the office, I took investigation kit and all necessary equipments. On the way I contacted with two local people and found two disinterested persons namely (i) Rakesh Tamang (42) S/O Lt. Kajiman Tamang of Sukiapokhari, P.S. - Jorebunglow, Dist. Darjeeling, at present Champasari, Kalimandir, P.S. - Pradhannagar, Dist. Darjeeling & (ii) Sri Bikram Thapa (38) S/O Lt Sukman Thapa of Champasari Anchal, PS Pradhan Nagar Dist. Darjeeling. Then I informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary. At about 14.45 hrs, we arrived near S.N.T bus stand, Siliguri Junction under Pradhannagar PS and as pointed by the source we found that one person is standing at S.N.T bus stand. Accordingly, we intercepted him. On being asked the intercepted person disclosed his identity as noted above. On further asked about the contains of his Hand bag, he stated that it contains Capsul for supply the same at Junction area.

Then we detained him with strong reason to believe that the said person is illegally possessing & selling the contraband Capsul inside the hand bag. After disclosing our identity, I asked him in writing, whether he wants to be searched in presence of Executive Magistrate or Gazetted Officer for the process of Search and he agreed to be searched by any one of the two. Subsequently, I contacted to the Sri Subasish Chaki, I/C Pradhannagar PS SPC and requested to come to the spot and supervise the entire process of search and seizure as per law. Sri Subasish Chaki, I/C PS SPC arrived at the spot at 15.05 hrs. He discloses his identity before apprehended person as gazetted officer and he has been offered to search the police team as well as gazette officer and witnesses but he refused. Thereafter the process of the search was started.

Then, as per direction and under supervision of Sri Babhushin Chakki, I commenced search his bag and found above noted contraband Winspasmo forte Capsul containing Tramadol. On asking he failed to produce any valid documents in support of the contraband Tramadol Capsul. Then I seized the above noted articles, throughout the sealing and labeling by preparing proper seizure list. The entire search, Seizure, label process has made between 15.25 hrs to 16.15 hrs. And arrested the apprehended person namely **Bikram Tamang (23) S/o Thendup Tamang of Hamchi Bazar, Gantak road, P.S-Namchi, Dist. East Sikkim, Sikkim** for violating NDPS norms after maintaining all formalities regarding arrest.

In the above circumstance, I pray before you to take the seized articles and sample & arrested accused persons namely **Bikram Tamang (23) S/o Thendup Tamang of Hamchi Bazar, Gantak road, P.S-Namchi, Dist. East Sikkim, Sikkim** and started a specific case against the arrested accused person under proper section of law and arrange for its investigation.
