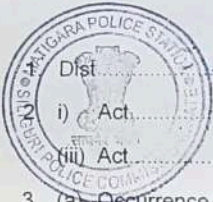

In producing herewith one accused person named Bappa Dey (30), S/O- Sandip Dey of Kawakjali Bazar, PO Sushratanagar, PS Matigara, Dist - Darjeeling under arrest along with following articles under proper seizure.

1. One drum containing 35 liters of illicitly distilled liquor and marked as Exhibit - A.
2. One bottle containing 600 ml of illicitly distilled liquor extracted from Exhibit - A as sample for examination and marked as Exhibit A-1
3. One drum containing 35 liters of illicitly distilled liquor and marked as Exhibit - B.
4. One bottle containing 600 ml of illicitly distilled liquor extracted from Exhibit - B as sample for examination and marked as Exhibit B-1.
5. One plastic jar containing 05 liters of illicitly distilled liquor and marked as Exhibit - C.
6. One bottle containing 150 ml of illicitly distilled liquor extracted from Exhibit C as sample for examination and marked as Exhibit C-1.

I, SI Abhishek Theengh of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Bappa Dey (30), S/O- Sandip Dey of Kawakjali Bazar, PO Sushratanagar, PS Matigara, Dist - Darjeeling to the effect that today on 13.03.2022 at 21.50 hrs received a source information that one person is selling liquor in a house situated at Kawakhali area under Matigara Police Station without any valid license. Accordingly I informed the matter to the O/C PS and as per his kind direction I along with C/1035 Santosh Rabidas, C/1008 Kanak Roy, and CV-155 Sukumar Das had been to Kawakhali bazar area under Matigara PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was storing and selling illicitly distilled liquor at his house. Accordingly, I with the help of my accompanied force cordoned the house and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the house. Further being searched the above noted seized articles were found from his conscious possession. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Bappa Dey (30), S/O- Sandip Dey of Kawakjali Bazar, PO Sushratanagar, PS Matigara, Dist - Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 22:20 hrs to 22:50 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Bappa Dey (30), S/O- Sandip Dey of Kawakjali Bazar, PO Sushratanagar, PS Matigara, Dist - Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
