Jamaluddin Sk of Ramnagar, Bil Borakpara, PS Lalgola, Dist. Mursidabad, Bilbora Kopra, West Bengal, 742148, (iii) Prabha Mallick Duwara (32 yrs) S/O Gajen Duwara, PO Bekadolang, Vill. No. 2, Laloti Potharm Lolati Pothar No. 2, PS Sonari, Dist. Sibsagar, Assam- 785690 along with seized articles as per seizure list

Duwara, PO Bekadolang, Vill. No. 2, Laloti Potharm Lolati Pothar No. 2, Sibsagar, Assam- 785690 was found. Three mobile were also found in the bag the details of which are one black colour NOKIA keypad mobile phone having IMEI No. 357731103352414 bearing SIM Card styled as Airtel 4G bearing ICCID No. 891160990010347013U, one black colour NOKIA keypad mobile phone having IMEI No. 35779100174325 with no SIM Card and one dark grey colour INFINIX touch screen mobile phone having IMEI No. 353008484567520/353008484567538 bearing SIM Card styled as JIO bearing ICCID No. 89918350400085308932. Cash of Rs 4000/- in various denominations were recovered as her personal property.

Thus, a reasonable belief having been formed that an offence has been committed in contravention of the section 8C r/w 22 of the NDPS Act, 1985 (as amended) and that recovered articles were liable to be confiscated U/S-60 & 61 of the NDPS Act, 1985, the entire contraband believed to be heroin were seized U/S- 43 of the NDPS Act, 1985 (as amended) under proper seizure list duly prepared by me. Took dated signature of the witness, all the three owners of the goods, police personnel's, signature of DySP, Sudip Bhattacharjee as gazetted officer and put my signature as seizing officer. Copy of seizure list given to the detained persons.

Thereafter all the seized articles have been properly labelled sealed with brass seal (STF WB SILIGURI). Took signature of all the police personnel, witness, and all three owners of contraband goods in the labels and marked accordingly. Thereafter I have arrested above noted three persons after communicating their ground of arrest and issued arrest memo accordingly. Prepared Inventory list, took specimen seal impression of brass seal (STF WB SILIGURI).

Under the above circumstances a case under section 18/21(c)/22(c)/27A/28/29 of NDPS Act, 1985 may kindly be started against the three accused persons namely (i) Sher Bahadur Tamang (58) S/O Lt. Bahadur Tamang of H/No. 91/A near Zion Hospital, Model Colony, Purana Bazar A, PS Dimapur, Nagaland 797116, (ii) Md. Sofikul Islam (30) S/O Md. Jamaluddin Sk of Ramnagar, Bil Borakpara, PS Lalgola, Mursidabad, Bilbora Kopra, West Bengal, 742148, (iii) Prabha Mallick Duwara (32) W/O Gajen Duwara, PO Bekadolang, Vill. No. 2, Laloti Potharm Lolati Pothar No. 2, PS Sonari, Dist. Sibsagar, Assam- 785690 and others involved in this racket.

Superiors of STF, WB have been apprised of the seizure, arrest and other proceedings made so far in this regard.


S.I. Sangay Lama Tamang of Special Task Force, West Bengal, HQ at Siliguri will investigate the case as per order of superiors.


