Sir,  
With due respect, I am producing herewith one arrested accused person namely Dulal Roy (52 yrs) S/O late Roshni Roy of Baribhasa, PS- NJP, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15 (Fifteen) bottles of 60 Up Himalayan Gold Country Spirit containing 600 ML in each bottle.
2. 05 (Five) Bottles of Mc Dowelle's No-1 Premium Whisky containing 375 ML in each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 13.03.22 at 19.25 hrs I received a secret source information that one person namely Dulal Roy of Baribhasa, PS- NJP, Dist- Jalpaiguri is selling ID liquor illegally at his residence at Baribhasa under PS- NJP, Dist- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 593 dated 13.03.22 and informed the fact to you. As per your kind direction and instruction myself along with C/1053 Pareswari Rava, VP/08 Laxman Roy, VP/13 Jamirul Islam and CV/306 Biswajit Roy and others all of NJP PS, SPC left for Baribhasa, PS- NJP to work out the information in hand. At about 19.45 hrs we arrived at the residence of accused Dulal Roy S/O late Roshni Roy of Baribhasa, PS- NJP, Dist- Jalpaiguri and being identified by the source, I held rald at the said residence and managed to apprehended one person. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his residence. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 20.05 hrs 20.40 hrs on 13.03.22.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dulal Roy (52 yrs) S/O late Roshni Roy of Baribhasa, PS- NJP, Dist- Jalpaiguri and arrange for its investigation.
