I Tarun Sharma son of Shri Rajendra Prasad Sharma, advocate by profession, resident of Golden apartment Shivmandir road, Punjabipara, ward no. 13, Siliguri, do hereby lodge the written complaints against Pravin Agarwal son of Lt. Om Prakash Agrawal, resident of 100 pearls apartment Jyoti Nagar, Siliguri, District Jalpaiguri having his mobile number 983 2181 269 engage me to defend his brother Amit Agrawal and family members and connection with Bhaktinagar PS case number 1466/2021 dated 15/11/2020 I secure release of of the female accused from the Police Station in accordance with law and Ld. Court release the male accused considering the nature of offence and peculiar facts and circumstances of the case. As Pravin Agarwal is known to me e since last more or less 4 years he promised to clear my professional fees within a week but fail to do so till today . On last appearance date of Amit Agrawal and others before the Court of law I came to know that Pravin Agarwal had already received the sum of rupees 7 lakhs in total from Shri Manoj Agarwal(jijaji of Amit) as legal fees when I ask Pravin to refund the same to see Manoj Agarwal he started abusing me in filthy languages all these where brought to your notice by written complain dated 21/02/2022. Since then he became more roudy and arrogant and started to abuse me and threatened me and Sri Manoj Agarwal with dire consequences on 7/03/2022 as per your direction Shri Manoj Agarwal appeared before your good office and narrated the entire facts to you corrabiting my allegation against Pravin Agarwal after that late night Pravin Agarwal called me up on my mobile being no 8250119971 and started abusing me making derogatory remarks towards my mom and sister and when I opposed the same he started threatened me with their consequences and all this are available in my call record.

The threatening call of Pravin Agrawal was not taken as serious as it should have been taken. The Pravin Agarwal along with some hooligan about 6:30 p.m.9/03/2022 wearing a black mask attacked me at Don Bosco road as I was having helmet I scape the injury when I shouted for help on the way of their running they threw a bottle targeting me which contained chemical of corrosive character with an intention to cause badly injury leading to scars.

Therefore it is requested to you to look into the matter seriously and do the needful as per law.
