In producing herewith one person namely Sachin Lepcha (42) S/O Late Tshring Lepcha of Panighata road PS, Bagdogra Dist, Darjeeling along with the following articles under seizure viz,

1. 18 (Eighteen) Bottle of Kingfisher Strong Premium Beer (each bottle containing 650 ml) Marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",
2. 8 (Eight) Bottle of Emboss fine whisky (each bottle containing 750 ml) Marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1",
3. 6 (Six) Bottle of Mc-Dowell's no1 celebration deluxe RUM (each bottle containing 750 ml) Marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1",
4. 4 (Four) Bottle of Blue Time premium Whisky (each bottle containing 750 ml) Marked as Exhibit "D" from which 01 bottle randomly taken out as sample and marked as Exhibit "D-1",

I, ASI Dharendra Nath Manda of Bagdogra Police Station, SPC do hereby lodged this written complaint against the above noted arrested person namely Sachin Lepcha (42) S/O Late Tshring Lepcha of Panighata road PS, Bagdogra Dist, Darjeeling to the effect that on 16.03.2022 at evening in course of special mobile duty along with force vide Bagdogra PS, GDE no 1108 Dtd, 16.03.2022 at around 17.05 hrs received a reliable source information that one person Sachin Lepcha is selling huge quantity of illicit liquors from his shop accordingly, I informed the mater to OC, PS and as per his kind direction I, along with force rushed at Panighata road Upper Bagdogra one shop source point out the shop in a distance we cordon the shop and apprehended the above noted arrested person who is selling illicit liquors some of his designated customers clandestinely from his shop during the time of pandemic situation as well as holi festival in a high rate seeing the police party some customers were flee away to run from the shop. On interrogation Sachin Lepcha admitted that he is the owner of the shop and run the business since long time for his wrongful gain previously he also arrested. Subsequently the above noted huge illicit liquors were found on his shop on demand he failed to produce any valid documents/papers or license in support of storing and selling of the said huge illicit liquor. Accordingly, I seized the above mentioned illicit liquor recovered on his shop under proper seizure list in presence of local witness and labelled also arrested him u/s 41 CrPC issuing memo of arrest inform his ground of arrest. The whole process of seizure and labelled was made in between 17.45 hrs to hrs to 18.50 hrs. Total 25.200 ltrs illicit liquors on different brands.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted Sachin Lepcha (42) S/O Late Tshring Lepcha of Panighata road PS, Bagdogra Dist, Darjeeling and arrange for its investigation.
