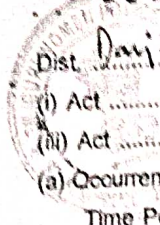

Respected Sir/Madam,

I, **SMT. PRIYA (NAHAR) JAIN**, Wife of Sri Nitin Kumar Nahar and Daughter of Shanti Jain, presently residing at D01/02 D1 Block, Uttarayon Township, Matigara, Siliguri-734010, P.O. & P.S. Siliguri, District – Darjeeling would like to inform and request you as follows:

1. That I am married to Sri Nitin Kumar Nahar, Son of Sri Nirmal Kumar Nahar and our marriage was solemnized on 23.11.2017 at Eagleton Golf Resort, Bangalore and the same was also registered on 21.12.2017 at Basavanagudi, Bangalore.
2. That after our marriage, I started to reside at my matrimonial house situated at No. 29/1 Panchratna Apartment, 1st Floor, Govindappa Road, Basavanagudi, Bangalore-560004 with my husband, father-in-law (Sri Nirmal Kumar Nahar) and mother-in-law (Smt. Sunita Nahar).
3. That soon after our marriage my mother-in-law started to show her dissatisfaction regarding the gift, jewellery and other items given by my parents. However when I communicated the same to my husband, he assured to look into the matter but never took any step.
4. That on 07.12.2017, I along with my husband came to Siliguri to attend my cousin's marriage which was being held at Maheshwari Bhawan, after attending the function when we returned back to my parent's place at Milanpally (old residence), my husband started yelling at me and my parents for the amount of money that was given to him in Tilak, my parents were insulted for the standards being so low and after all this he yelled at me and tortured me mentally stating that he is no match for the standards of my family, this took away my mental peace and my mother-in-law persuaded us to return back to Bangalore on 10.12.2017 and we were left with no other option but to reschedule our tickets and return to Bangalore.
5. That prior to my marriage, I was made to believe that I would be allowed to work but when I along with my husband started a office to pursue my career, my mother-in law never favored my decision and finally I had to give in and shut down my office but owing to the values given to me by my parents, I always made every effort to deal with the miserable situation and keep quiet for the peace of the family.
6. That with time I realized that my mother-in-law was very aggressive and did not allow me to get along with my relatives or other residents of the building. My mother-in-law

14. That to my dismay, my husband and in-laws did not turn up and when I called to enquired about the matter, they assured me that they would come for my brother's marriage but their promises were shallow and false.
15. That in the month of August 2021, when I was 6 months pregnant during a conversation with my mother-in-laws, I expressed my willingness to get my delivery done in Siliguri as the pandemic of Covid- 19 was prevalent and I preferred the doctor in Siliguri to which my in-law got furious and started yelling at me stating that if I get the child delivered in Siliguri, it shall has no relation with their family and also said that I should not call or message my husband.
16. That after the conversation in the month of August 2021, my husband or his family members did not bother to call or reconcile with me, neither I tried calling them as it was strictly said by my mother-in-law to not to call or message my husband.
17. That on 25.11.2021, I was blessed with a baby girl at A H IVF & Infertility Research Centre situated at Shivmandir, Siliguri and during this period neither my husband nor my in-laws came to meet me or even call to ask me about my health or the well-being of the child.
18. That on the birth of the child we came to know that the child oxygen level was low and she was immediately taken and admitted to other hospital i.e. Neotia Getwel Healthcare Centre situated at Uttorayon Township, Matigara, Siliguri. But during the admission, the doctors demanded for the Aadhar Card of Nitin and for the sake of my child my brother texted my husband but he did not even bothered to reply or send the document.
19. That this incident left me heartbroken, it clearly showed that my husband have no attachment, love or empathy for his wife or child. It has been around 3 months of my child birth and no-one from my matrimonial family cared to contact us. Infact my mother-in law has started sharing rumors about my character and behavior in the society.
20. That neither my husband and nor my in-laws have contacted by themselves but their relative i.e. Smt. Renu Singhi who lives in Pune called me and my father and falsely accusing us of blackmailing them, which is not a true fact.
21. That I am in the state of true perfidy and have been residing with my parents since past 10 months with merely no source of income and an infant. In 4 years of this marriage, I had selflessly given in this relationship emotionally, physically, mentally and demanded nothing but self-respect, support and love which I was deprived off and now I am in the state of helplessness and all my endurance have failed.

Therefore you are humbly requested to look after the matter and take strict action against the aforesaid culprits and initiate a criminal case against them under section 498A and other sections as you may deem fit and proper.
