Dear Sir,

I am Prashant Kumar Ojha, aged 42, S/O Shri Shyam.Sundar Ojha resident of B-304, D1- Block, sector- 1, Shaitan singh vihar, AWHO, Vidhyadharnagar, Jaipur (Rajasthan) 302039 make an written application to your good office on behalf of my younger Brother Mr Sushant Ojha, aged 38, S/ O. Shri Shyam Sundar Ojha, resident of B-51, Vandana Nagar, Indore (Madhya Pradesh).

My Brother has informed me over phone that they recently attended a family wedding in his in laws family in Siliguri (West Bengal) along with his wife and kid.

An unfortunate incident of theft was informed by his wife Prity Ojha W/O Shri sushant Ojha resident of B-51, Vandana Nagar, Indore (Madhya Pradesh) to him on 20<sup>th</sup> February 2022 Morning that after coming back from Siliguri to Guwahati, while unpacking the luggage around 9 am she discovers that jewelry (Details mentioned below as annexure-1) for an amount of Rs 10- 12 lakhs was missing from the luggage bag. She also informed that her Mother ( Mrs Shanti Devi Saraswa W/ O late Mahesh Saraswa resident of Guwahati) & her Sister-in-law ( Mrs Pooja Saraswa W/O Shri Mukesh Saraswa resident of Guwahati) together has also lost Jewelry for an amount of Rs 20- 25 lakhs while attending the marriage function at Hotel Montana Vista, Siliguri (West Bengal) on 19-02-2021. All three above-mentioned ladies had stayed together along with Mr Mukesh Saraswa S/o late Shri Mahesh Saraswa resident of Guwahati (Assam) and one relative in room no 214 of the hotel between 17-02-2022 till the evening of 19-02-2022. She has last check the jewelry around 2.30 pm of 19-02-2022 and it was available in the bag so She has doubt that jewelry of all three members were lost from their bags from the hotel room where they had stayed together.

My Brother after the above mentioned information has visited the Guwahati and Siliguri to seek the local relatives/ resident support and also visited the hotel Montana vista to check if they had any information available on the missing jewelry but did not got any clue from the hotel. Since my brother is working professional and has already taken many leaves in last one month so he decided to seek family support and informed me to lodge compliant on his behalf. So, I Under signed on behalf of my younger brother and family request you to lodge compliant and help us recovering the missing jewelry.
