I Ruchika Kindo Daughter of- Nirdosh Kindo R/o- Kalamjote Near Chuwal Singh More, Siliguri, Dist-Darjeeling in the state of West Bengal do hereby writes you for your kind information and necessary action as follows:

1. That I was studying in class-IX, in the year of-2016 at B.S.F. Kadamtala School situated at Kadamtala More, during the time of study I met with a Boy Namely Ruhani Zia who is my classmate in my above named school.
2. That I was in relationship with Ruhani and several time he tried to seduce me but when I refuse then he tried to torture me physically and mentally. It is pertinent to mention here that ruhani failed in the final exam of Class-IX and he left school.
3. Surprisingly once again Ruhani joined our school in the year of 2019 as a student of class-XI and during that time I was studying in class-XII in the above-mentioned school. And once again our relationship started with a hope of new faith and trust.
4. That after one month of our relationship once again Ruhani tried to seduce me for his physical gain but when I refused to do so he tortured me in such a filthy way which cannot be explained in any words.
5. That ruhani also posted my various photos on social media sites with filthy comments, when I was able to know that I was breaking up my relationship with ruhani but still he was doing the same.

That after the breakup I decided to move on but suddenly on dated- 22nd January 2021 I got a message on my Instagram- by the user namely- **Mamunalam** and he started chat with me as unknown person but when I checked his profile and asked him that whether he is ruhani or not and after several days of it he accepted that yes I am ruhani.
7. After the same he started to chat with me by his instagram Id and we exchanged our mobile no with each other. After that he started a video call on my no and asked me to send my images to him but I refused all time.
8. That once in the month of September 2021 he threaten me if I will not show him my body then he will suicide I was afraid and I was accepted his offer but he recorded the video call and he always tried to seduce me and blackmailed me by way of the nude recording.
9. Then when he tried to blackmail me I blocked him on instagram, but yet he tried to blackmail me with another mobile nos, several times he threatened me that if I will not accept his offer then he will publicize the whole video and images on social media sites.
10. He also blackmailed my brother by sending messages on whatsapp and on telegram. We were so afraid and we think that he is doing all this stuff due to the breakup.
11. When I told these things to my parents they visited the house of Ruhani and asked his parents about these things and his parents told my parents that Ruhani will not act the same way in future.
12. After the meeting of our parents in november-2021, everything became normal but suddenly in January -2022 ruhani sent an email in our college with some nude photos and videos of mine and I got a call from my principal and he told me these.
13. That as a known person of society I was silent for years but now my all patience level has ended. And now I am tired that each and every day he is blackmailing me for dire consequence and due to his act several times I think to end my life, but I couldn't due to the love and affection of my family.
