Respected Sir

I, Pravin Agarwal son of Sri Krishna Kumar Agarwal, resident of E/4, Gulmohar Apartment, ITI Road, Siliguri, Ward No. 41 of S.M.C, P.O. Siliguri, P.S. Bhaktinagar, District Jalpaiguri, Pin 734001, would like to bring to your notice that yesterday night i.e. 15.03.2022 me and my wife visited Savin Kingdom "Carnival" for watching the movie namely "Kashmir file" show time was 20:45 hrs. and our seat no. was C/7 & C/8 in Screen No. 2 and while we were watching the movie the four miscreants alongwith one lady suddenly came in front of us and when requested them to leave the place they became violent and started quarrel with us and using filthy language and provoking me to meet outside of the Savin Kingdom with him due to his provocation and though the matter was related to my self-esteem I asked them what is the issue and why you are doing like this?

That one person amongst them tried to misbehave with my wife and when I tried to resist him other three person alongwith one lady suddenly hit me push me hard and they were literally abusing me. They slapped me, hit me and tried to strangulate me also and thereafter snatched away my gold chain.

Thereafter we rushed to Siliguri District Hospital for my treatment as I was badly injured by such merciously beating which are very painful for me and still my treatment is going on.
