With due respect and humble submission, in producing herewith following seized articles under proper seizure,

- i) **16(Sixteen ) bottles of Himalayan Gold country Spirit 60\*up each bottle contains @ 600 ml each.**

I ASI Asit Singha of Pradhannagar PS, SPC would like to lodge this written complainant against one Bishnu Oraon S/o Lt. Hindu Oraon of Parvati Ghat more ward no-45, Baghajotin Colony PS Pradhan Nagar Dist Darjeeling( Absconding) to the effect that today on 16.03.2022 when I along with C/974 Mintu Sen, CV/128 Ajay Sahani,CV/242 Rakesh Mangar were performing Special van duty vide PDN PS GDE NO 1009 dtd. 16.03.2022.I received an information that Liquor is being sold illegally from house cum Shop .Accordingly, I sharing the information to you and as per your kind instruction myself along with force rushed to the spot and held raid at his house. Seeing Police Party owner of the house namely Bishnu Oraon S/o Lt. Hindu Oraon of Parvati Ghat more ward no-45, Baghajotin Colony PS Pradhan Nagar Dist Darjeeling fled away from the house. Search was conducted at his house cum shop on search recovered above noted articles, also found Pachai approx 30 Kgs, Which is destroyed on the spot .On local enquiry it could be learnt that the person has been selling illegal liquor since long for his illegal gain and disturb the peace and tranquility of the area. Accordingly, I seized & label the above noted articles in between **20:40 hrs 21:25 hrs** under Proper seizure list.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Bishnu Oraon S/o Lt. Hindu Oraon of Parvati Ghat more ward no-45, Baghajotin Colony PS Pradhan Nagar Dist Darjeeling( Absconding) and arrange for its investigation.
