At Around 09:30 hrs today on 15.03.2022 morning the undersigned received information regarding damage of electric lines along with Transformer Structure at Sevoke Road, Opposite Sona Petrol Pump, Salugara Siliguri, P.S Bhaktinagar, Dist- Jalpaiguri. On reaching the site It was reported by Technical staff that, one Truck having Vehicle no RJ-01-GB-9257, While driving had damage Electric Transformer Structure and caused other damages to the Electric Lines which was the property of WBSEDCL. The total damages caused by the vehicle is approximately around Rs 25332/- (Twenty Five Thousand Three Hundred and Thirty Two). Thus you are requested to kindly initiate an investigation against vehicle no RJ-01-GB-9257, under Section 139 of the Indian Electricity act 2003 amended on 2007.
