(1) 40 (Forty ) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 20.4 Liters & Amount Rs 4800/-).

I SI Pradip Kr Singha of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely Suraj Shaw (26), S/O- Firoj Shaw of Khudiram Coloney. PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 17.03.2022 evening as per order of O/C Ashighar OP I along with ASI Inzamamul Hoque C/877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigarh OP as per order vide Ashighar OP GDE no. 403 Dt 17.03.2022 in course of which I received information from my source that one Suraj Shaw stored a huge numbers of bottles of liquor inside his house at Khudiram Coloney and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Khudiram Coloney to verify the veracity of information. On the way I called two local person namely (1) Dilip Das (37) S/O Kali Charan Das of Niranjan Nagar Ghogomali PS Bhaktinager Dist. Jalpaiguri and (2) Ajay Sarkar (32) S/O Sunil Sarkar of Ghogomali PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Khudiram Coloney area as indicated by my source I held raid at the house of Suraj Shaw at Khudiram Coloney .But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house . I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 19.25 hrs and 19.45 hrs on 17.03.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Suraj Shaw (26), S/O- Firoj Shaw of Khudiram Coloney PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
