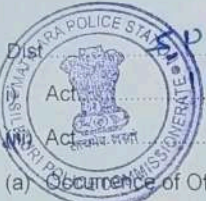

threatening intention of hurting me and my family.

Hence in this context I did not allow her to come inside my
house.

Which made her violent and she started throwing stones on my
house.

On this event I called the local Matigara Police Station.

She even threw stones on me and my wife.

She broke several glass window panes and doors thus hampering
the safety of our family.

She even tried to kill my wife by choking her throat and bite
her.

After 45 minutes the police came and took ^{necessary steps to} ~~her to the police~~

I have a grandson of 5 years who was very scared and she even
tried to hurt my grandson by throwing stones. On this context
