Sir,

I, PSI Abhishek Theengh of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Bittu Kisku (25) S/O Dhuma Kisku of Purba Rangia, P.O- New Rangia, P.S- Matigara, Dist.- Darjeeling under arrest along with following seized articles viz ; 1] 09 (Nine) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 5.4 liters, value Rs.120X9=1080/-), and marked as 'exhibit -A' and 2] one bottle Himalayan Gold 60 UP Country Spirit taken out from exhibit -A as sample for examination and marked as "exhibit A-1" under seizure list (which is enclosed herewith) to the effect that on 17.03.2022 at 19.15 hrs. received a secret source information that one person namely Bittu Kisku (25) S/O Dhuma Kisku of Purba Rangia, P.O- New Rangia, P.S- Matigara, Dist.- Darjeeling has stored huge quantity of Illegal liquor at his shop without any valid license. Diarized the matter vide Matigara PS GDE No.1363 Dt.- 17.03.2022 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with Const- 1035 Santosh Rabi Das, CV- 155 Sukumar Das left for Purba Rangia under Matigara P.S to verify the veracity of the source information. On reaching at the spot at 19.55 hrs it was found that huge quantity of illegal Liquor stored in the shop of Bittu Kisku who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the shop. But we apprehend the above noted person namely Bittu Kisku. Thereafter, in the very presence of two available witnesses I search the shop and seized illegal Liquor after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Bittu Kisku. On being asked the said person failed to produce any document for selling and storing of illegal Liquor at the shop. It's a violation under Bengal Excise Act. This seizure was made on 17.03.2022 in between 20.25 hrs to 20.45 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Bittu Kisku (25) S/O Dhuma Kisku of Purba Rangia, P.O- New Rangia, P.S- Matigara, Dist.- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of illegal Liquor at the said shop and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Bittu Kisku (25) S/O Dhuma Kisku of Purba Rangia, P.O- New Rangia, P.S- Matigara, Dist.- Darjeeling and arrange for its investigation.
