Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Tanmoy Halder (present user), Haren Mukherjee Road, Opp Yellow House, Hakimpara, Siliguri, Dist- Darjeeling for having committed offence as stated here under..

On 15.03.2022 at about 01.00 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Sudipta Moitra, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Tanmoy Halder (present user), Haren Mukherjee Road, Opp Yellow House, Hakimpara, Siliguri, Dist- Darjeeling and inspected service installation, metering installation of Consumer ID 412151973 in the name of SWAPAN KR. HALDER. During inspection it was found that electricity was being used unauthorisedly & illegally by Tanmoy Halder (present user) by reconnecting the disconnected service line of the metering installation that was disconnected previously on 17.08.2016 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Bentec Electricals & Elec. Ltd., serial no.- B3797614 installed against Con Id. 412151973 seized by preparing a formal seizure list duly signed by representative of Tanmoy Halder and witnesses. The copy of the seizure list handed over to representative of Tanmoy Halder and his signature obtained as token of receipt.

As Tanmoy Halder has committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
