I Bisheswar Ram S/o Lt Faguni Ram R/o Airport More Gwoala Basti P.O + P.S Bagdogra would like to inform you that at around 6:40 pm when I was sitting in my house with my family members I heard Dewender Ram S/o Thapsi Ram R/o Gwoala Basti Airport More, Thapsi Ram S/o Dhawik Ram R/o The Above Mentioned Address and all of them their family members gathered right out side my house and were continuously using Abusive words and Slang languages against me and my family members when me and my son namely Chandan Ram stopped them from doing the same they became so furious and started beating me and my son mercilessly with fist and blows and suddenly Dewender Ram struck my head with iron rod with the intention to kill me and tried to choke my neck with rope

Devender Ram along with all his family members also tried to beat my wife namely Renu Devi w/o Bishwas Ram R/o Above mentioned Address they also tried to touch the private parts of my wife and tried to disrobe her.

Out of the said Assault I got severely injured and had sustained severe injuries over my head and I have suffered 3 stitches over my head and I have also took medical attention from Bagdogra primary health check up center.

finding no way out I am filing this F.I.R so that proper necessary legal action is taken against them.
