Sir,

With due respect, I am producing herewith one arrested accused person namely Rajib Roy (36 yrs) S/O Nabol Kishor Roy of Tinbatti Colony, Ward No-32, PS- NJP, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 11 (Eleven) bottles of 60 Up Himalayan Gold Country Spirit containing 600 ML in each bottle.

I, ASI Khagen Barman presently attached with NJP PS under your kind control beg to state that today i.e. on 15.03.22 at 18.15 hrs I received a secret source information that one person namely Rajib Roy of Tinbatti Colony, PS- NJP, Dist- Jalpaiguri is selling ID liquor illegally at his shop at Tinbatti More under PS- NJP, Dist- Jalpaiguri. Accordingly, I clarified the fact in the General diary vide NJP PS GDE No 675 dated 15.03.22 and informed the fact to you. As per your kind direction and instruction myself along with C/1053 Parash Rava, VP/08 Laxman Roy, VP/13 Jamirul Islam and CV/306 Biswajit Roy and others all of NJP PS, SPC left for Tinbatti More , PS- NJP to work out the information in hand. At about 18.45 hrs we arrived at the shop of accused Rajib Roy S/O Nabol Kishor Roy of Tinbatti Colony, Ward No-32, PS- NJP, Dist- Jalpaiguri and being identified by the source, I held raid at the said shop and managed to apprehended one person. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 19.15 hrs 19.55 hrs on 15.03.22.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Rajib Roy (36 yrs) S/O Nabol Kishor Roy of Tinbatti Colony, Ward No-32, PS- NJP, Dist- Jalpaiguri and arrange for its investigation.
