The ground of arrest duly been communicated with him.

2. 36 (Thirty Six) Bottles of COPENHAGEN DENMARK TRADE T MARK "TUBORG" Premium Beer containing 650 Ml in each bottle.


I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 16.03.22 at 16.20 hrs I received a secret source information that one person namely Khokan Ghosh of Sahid Colony, Block - D, Bhakti Nagar, Ward No-35, PS- NJP, Dist- Jalpaiguri is storing huge quantity of Beer at his Hotel styled as Jamai Hotel, NJP. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 714 dated 16.03.22 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava, HG/794 Ranjit Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy and others all of NJP PS, SPC left for Jamai Hotel, NJP to work out the information in hand. At about 16.45 hrs we arrived at Jamai Hotel, NJP and being identified by the source, I held raid at the said hotel and managed to apprehended the owner of the said hotel. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor (Beer) at his hotel styled as Jamai Hotel since long for his illegal gain. On search the above noted I/D liquor (Beer) recovered from his Hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor (Beer) recovered from his Hotel. Accordingly, I seized the above noted I/D liquor (Beer) from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 17.15 hrs 18.25 hrs on 16.03.22.


