In producing herewith the 08 (Eight) arrested persons who disclosed their names & identities as; (1) Md. Mustafa [40 yrs] S/O- Lt. Md. Saddik, (2) Jitendra Prasad [40 yrs] S/O- Shyam Narayan Prasad, (3) Smt. Neha Prasad [40 yrs] W/O- Rabindra Kumar Prasad, (4) Smt. Mobina Khatoon [32 yrs] W/O- Md. Mustafa, (5) Bholu Paswan [49 yrs] S/O- Kapilev Prasad, (6) Shankar Podder [40 yrs] S/O- Lt. Kamaleswar Podder, (7) Jahir Khan [20 yrs] S/O- Md. Aazad & (8) Rabindra Prasad [43 yrs] S/O- Lt. Narsing Prasad all of Goyalapatty, Ward No- 4, PS- Siliguri, Dist- Darjeeling, who are under arrest in c/w the case, I SI Pappu Kumar Singh O/C, Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested accused persons and about 50 other unknown persons to the effect that, on 18.03.2022 at about 11.30 hrs while having an information of gathering and chaos between two groups of different communities at Goyalapatty, ward no- 4 under Siliguri PS, myself along with other officers and force had been to Goyalapatty and found that, two groups of peoples of different communities were engaged in street fight and exchanging hot altercations with deliberate and malicious act tried to outrage the religious feelings of each others. Considering the situation, I informed my superiors Officers for reinforcement. Meanwhile, I.C, Siliguri PS with his Officers and force arrived at the spot and we managed to stop both community peoples and deterred them to refrain from such malicious act. Meanwhile other superior Officers reached at the spot. Then we started using loudhailer to disperse the gatherings of both sides by declaring the gathering as unlawful assembly as per the order of present superior Officers. But people of both communities were adamant and they were still insulting religious beliefs of each other by uttering derogatory comments and showing disrespectful gesture and posture. They were also promoting enmity different groups on grounds. In spite of several warnings of dispersal through loudhailer when both the communities of peoples did not pay any heeds to our words, then finding no other alternatives, we chased them and arrested the above noted 08 accused persons from the spot and about 50 other members managed to fled away from the spot.

I, therefore, request you to start a specific case under Section 143/145/147/153A/295A/506 IPC against the above noted arrested 08 (eight) accused persons and about 50 other unknown persons of the same locality and adjacent areas and cause proper investigation in the interest of justice.
