Subject: FIR

Sir,

In producing herewith (02) two arrested accused persons namely 1] Rahul Mondal (24) s/o Gautam Mondal of upper BhanuNagar, Ward No. 43, PS Bhaktinagar, Dist. Jalpaiguri 2] Prem Khawas (37) s/o Shyam Bahadur Khawas of Bandagi, PS Kakarivita, Dist. Jhapa, Nepal and others along with following seized articles viz: -

1. One iron made hammer fitted with wooden handle weighing 960 grams approx seized from the possession of accused Rahul Mondal.
2. One iron made Rod measuring 119 cm (approx) lying at the spot.
3. One iron made Rod measuring 83 cm (approx) lying at the spot seized from the possession of Prem Khawas .

I, SI Sk. Tamzid Ali of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons to the effect that on the intervening night of 19.03.2022 and 20.03.2022 at about 23.45 Hrs received a source information that some 5 to 6 youths have assembled at the vacant land where the bushes are present, Near Bhawani Infotech, Gandhinagar, under Bhaktinagar PS, suspected to be making preparation to commit crime at the adjacent area. Accordingly the information was intimated to I/C Bhaktinagar PS and noted the fact in G.D vide Bhaktinagar PS GDE No-1398, Dated 19.03.2022 and as per his direction, at around 23.55 hrs myself along with, PSI Sailesh Subba, ASI Rabin Lama, C/374 Debraj Biswas, CVF/935 Biplab Roy, CVF/619 Dharmendra Roy, CVF/014 Labannomoy Barman left PS to verify the veracity of the information. This refers to Bhaktinagar PS G.D.E No - 1399, Dated 19.03.2022 & MCC No- 684/21 Dated 19.03.2022. Informed night mobile van officer SI Dwipendranath Bakshi with a request to remain present there. At around 00.05 hrs I along with force reached Gandhinagar and kept the vehicle at considerable distance. After that I, accompanied by force started moving towards the aforesaid place and as shown by the source we subsequently cordoned off the place and suspected persons with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from that place to execute their plan. Sensing the police had cordoned off, they tried to flee away from the spot but on hot chase we managed to apprehend above noted 02 (two) accused persons along with seized articles as mentioned above. However, the other three persons managed to flee away from the spot taking the advantage of darkness. On interrogation the apprehended accused persons admitted that they had assembled there to commit dacoity at the House at Bhaktinagar PS area. They also stated that other three persons fled away from the spot. On interrogation the arrested accused persons confessed that they had assembled there to commit dacoity at the house under Bhakti Nagar PS area. They also confessed that 03 (three) associates namely (1) Billow (2) Bijoy and (3) Rahul @ Dacoit are fled away from the spot.
