Some of the people spot by the forest officials, their name given below. The people called more locals and the mob assault the beat officer physically. After that they tried attempt to murder him and threat to kill him. To save the life of beat officer he fled away from the spot. The following people obstructed us to perform government duty as public servant and assaulted physically my beat officers and his team.

So therefore request you to kindly take an immediate action to this people and accept the FIR against them.
