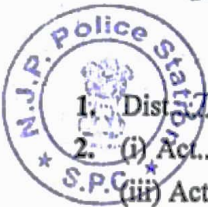

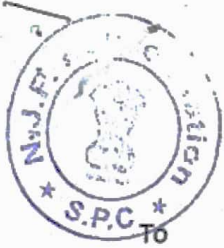

Sub- First Information Report against Balaram Ghosh and his entire family of three sons , three daughter inlaws and wife for forcefully trying to grab our land.

Respected Sir,

With due honour I Md. Taimur Asad Imran, S/o- Late Md. Amanulla, R/o- Dinbazar, Po.& Dist- Jalpaiguri, P.S. Kotwali,

Inform you that my mother Samsunnessa begum is the lawful owner in physical possession of the below scheduled landed property since the day of purchase.

That few years back the said Balaram Ghosh S/o- Late Lankeswar Ghosh, Resident of Purba Dhantala, P.O. Fulbari Hat, P.S. New Jalpaiguri, Dist- Jalpaiguri have been trying to grab the land and as a result my mother filed a civil suit against the said Balaram Ghosh In the Court of Learned Civil Judge ( Junior Division) at Jalpaiguri vide Title Suit no—159/2016

That the said Learned Court Decreed the case in favour of my mother vide order no 11 dated— 07/06/2018

That again the said Balaram Ghosh tried to enter in to the said plot of land on -07.03.22 and again the matter was reported to the Learned Court of Executive Magistrate Sadar at Jalpaiguri on 11/03/2022—vide Ptn R, No—268/22

That again the Learned Court wa pleased to pass an order directing the Opposite party not to disturb the possession of the petitioner.

That despite that fact today at around 3.45 am at around the said Balaram Ghosh his wife Basanti Ghosh his son Samrat Ghosh, Sonu Ghosh, Rubel Ghosh, his daughter inlaws of all three sons namely Maya Ghosh w/o- Sonu Ghosh, Pampa Ghosh W/o- Samrat Ghosh and Rupali ghosh w/o- Rubel Ghosh forcefully entered in to the said plot of land by breaking the tin boundry and set our security house ablaze by spreading oil on it. They also physically assaulted our security guards with deadly weapon with the intention to kill them. They also set ablaze the nearby sawmill in fire. One of my security guards mobile being no-8597061913 have been



snatched by them. I got the information through one of our family well wisher. They are absolutely land mafiyas and are very dangerous persons and may kill me at any point of time.

My mother is an old lady and is unable to move frequently hence I am taking care of the said plot of land.

I will be highly obliged to you if you kindly do the needful so that we can enjoy our property peacefully and can save ourselves from the hands of the culprits.
