I, Manoj Kumar Jaiswal, son of of Shri Bhikki Prasad, of Milanpally Siliguri, Ward number 25 of Siliguri Municipal Corporation, Siliguri bazar district Darjeeling West Bengal Pin - 734005 I would like to state as follows:

1. That I am the sole registered owner of five plots of land as recorded in my name in total measuring about 55 decimal situated at Jhugivita, Ambari, Falakata, by virtue of registered deed number 3226, 3227, 3228, 3229, 3230 and 3493 for the year 1997, Mouza - Jhugivita, Khatian no. 1429, J.L. no. 24, Dag No. 431, 432, 433, 434, Block Rajganj, District -Jalpaiguri.

2. That since last 25 years, i.e. from the year 1997, I was enjoying the peaceful possession of the above mentioned vacant land without any illegal interference and the said land was free from any encumbrances for any dispute as to my title over the said land. That since last few weeks I was constructing cemented boundary wall over my said land.

3. Yesterday (16-03-2022), when worker were ready for fencing at around 9:00 a.m., one Mr. Samarullah Islam of Harasangh, Jamadargacch, P.S. Bhaktinagar, District -Jalpaiguri - 735135, arrived at the site and threatened the worker and ordered them to stop the work and told them otherwise they have to face the consequences.

4. On 10-03-22, I have filed a title suit against Mr. Samarullah Islam and his wife Smt Rahena Khatun of Harasangh, Jamadargacch, P. S. Bhaktinagar, District - Jalpaiguri - 735136, in respect of the land as aforesaid, in the Court of Civil Judge Junior Division, at Jalpaiguri along with an injunction application. The Learned Court was pleased to pass an order restraining the aforesaid Mr Samarullah Islam, and his wife Rahena Khatun, from disturbing my peaceful possession and encroaching into my aforesaid land.

I, hereby request you to look into the matter and take necessary action against the named Mr. Samarullah Islam and his wife Mrs Rahena Khatun in accordance with the laws of the land and order of the the Learned Court is not violated.
