Court, Ward No. 29 SMC, P.O. & P.S. - Siliguri Distt - Darjeeling, beg to inform you that on Dt. 18.03.2022 at about 11:00 pm, ~~when~~ my relatives namely (1) Ganesh Biswas s/o Sri Rana Biswas (2) Nimai Biswas s/o Rana Biswas (3) Smt. Debi Biswas w/o Sri Ganesh Biswas (4) Smt. Purna Roy s/o Sri Chiranjit Roy all are of above noted address, started abusing my brother namely, Harichand Biswas s/o Late Bhalu Biswas of above noted address, ~~started~~ ~~abusing~~ and when me and my dear brother along with my wife Smt. Sumati Biswas (22), my sister namely Tulshi Biswas (18) s/o Late Bhalu Biswas & my aunty namely, Kirtika Biswas (40) w/o Sri Chittarajun Biswas all are of above noted address, started beating us brutally with fist & blows and they called Sri Karam Rana Biswas s/o Lt. Haralal Biswas of above noted address, and said Rana Biswas caught my sister Tulshi Biswas (18) & my wife Smt. Sumati Biswas (22) and he above named Ganesh Biswas & Nimai Biswas ~~took~~ ~~off~~ their clothes and disrobed, Tulshi Biswas & Smt. Sumati Biswas.

Sir, my father uncle Sri Chittarajun Biswas (42) s/o Lt. Haralal Biswas came home after that and immediately shifted me, my sister, Tulshi Biswas, my wife Smt. Sumati Biswas & my aunty, Smt. Kirtika Biswas to Siliguri Distt. Hospital & treated us there.

Sir, the above named alleged persons are very despotic & dangerous in nature and they have threatened us for dire consequences.

So, please take necessary action against (1) Ganesh Biswas (2) Nimai Biswas (3) Smt. Debi Biswas (4) Smt. Purna Roy (5) Rana Biswas noted above.
