beg to inform you that on St. 18.03.2022
at about 05.00 pm, when my husband namely
Sujat Kumar Gupta (38) S/o Sri Dewakar Prasad
Gupta, was at home at Bidyasagar Pally
on the occasion of Holi, at that time the
following persons came to our house and
took away my husband by their vehicle,
namely (1) Yogesh Gupta of Ganga Nagar (Mob
No. 7679877323) (2) Rabi Gupta S/o not
known (mob-9832466761) of M.L. Pally
along with other 02 (two) unknown persons
and requested to play Holi outside, and
they taken away my said husband, somewhere
at Ransdanga, & given him lots of alcoholic
drinks at their plots, and they all started
beating my husband with fist & blades and
injured him grievously, and threatened him
for dire consequences, and their intention
was to kill my husband. Thereafter the
said persons brought ^{back} my husband by
same vehicle and dropped him at my
doorstep at Bidyasagar Pally.

Next morning, i.e. on St. 19.03.2022
about 9 I shifted him to Siliguri Distt. Hospital
and treated himself there.

Sir, the above named alleged persons
are land mafias & anti social persons, and
they may again assault my husband.
