I, **SMT. SARASWATI DAS**, Wife of Sri Ganesh Das, presently residing at Santoshi Nagar, Machli More, Ward No.- 5, P.O & P.S. – Siliguri, Dist.- Darjeeling beg to inform you the following fact:-

1. That on **19-03-2022** at about **4.30 p.m.** when I and my husband namely Ganesh Das went to the house of Chandan Das at of Hemanta Basu Colony, P.O & P.S. – Siliguri, Dist.- Darjeeling at that time some of antisocial persons namely **i) LALU SINGH, son of not known ii) MD. BECHAN, son of not known iii) KHANIYA SHA, son of not known and 10 Others**, all are resident of Hemanta Basu Colony, P.O & P.S. – Siliguri, Dist.- Darjeeling enter into chandan's house with deadly weapon and started assault me and my husband with deadly weapon i.e. bhujali, sword and rods and by fist and blows and by kicks and due to their act my husband got severe cut injury on his head and blood woozes out from his head and all outrage my modesty by using filthy and offensive languages and try to unclotme me and put colour on my body forcefully and also snatches my gold chain from my neck.
2. That due to their act my husband became senseless at the spot and when neighbour came their for rescue all of them fled away and thereafter with the help of para people my husband admitted to NBMCH Hospital and my said husband is in serious condition and husband's life is in critical and serious condition and my husband fighting for his life in hospital
3. They above named persons are very dangerous and desparate in nature and my life under risk and I spend my life in very fear condition.
