That due to their act my husband became senseless at the spot and when neighbour came their for rescue all of them field away and thereafter with the help of para people my husband admitted to NBMCH Hospital and my said husband is in serious condition and husband's life is in critical and serious condition and my husband fighting for his life in hospital
 - 3. They above named persons are very dangerous and desparate in nature and my life under risk and I spend my life in very fear condition.
