sub: Complaint reg. Criminal trespass, intimidation, forcing to leave place of residence by some miscreants.

Sir,

In reference to the above, I am to state that I am Malati Roy (70) W/O-Kalu Roy along with my family have been residing near by a ditch at Hatidanga under Binnaguri Mouza, JL NO-160 pertaining to sheet no-3 under Ashighar out post, ps-Bhaktinagar Dist-Jalpaiguri Since 1971 as borgadar/permissive occupancy of one Barun Ghosh of Rabindranagar, Siliguri. We are belonged to Scheduled Caste community by caste Rajbangshi"

On 14/11/2021 at around at 15:00 hrs, some land Mafia namely Gadan Bhattacharjee s/o- Not known of Subhas pally (in front of the street of EX MIC Ashok Bhattacharjee), ps- Siliguri, Bini Chowdhury of Rabindranagar and 7/8 unknown others in furtherance of their common intention forcibly committed house trespas with criminal intimidation. Thereafter, they threatened me and my daughter in-law Minati Roy to leave the place of our stay stating that they had purched the said land. They took photograph of our huts and goats tied there with rope in front our house. They also conducted messurement of our huts and warned us stating that they would soon demolish our houses. On 28/11/2021 at around 23:35 hrs, some unknown miscreants thronged nearby our house and assaulted one Tapu Singh forcing him to call me in such odd hours of night. Significantly, on 5/3/2022 at around 10:00 hrs, while I was proceeding towards Santinagar an unknown person (driver of a Maruti car) tried to restrain me near Amtola road with his vehicle. Now, I am scared that they might again come to assault me and others.

In this context, it may be pertinent to mention here that in the year 2013, some miscreants / land Mafias hatched conspiracy and murdered my son Dhiren Roy. This has a reference vide Bhaktinagar PS Case No- 1818/2013 U/S 302/120 B /34 IPC.

Since I was sick and admitted to NBMC Hospital, Siliguri there has been delay lodging this complaint. The scribe who wrote this complaint has interpreted me in Bengali, which I admitted to be correctly written. The complaint has been written in accordance with my version and, being comprehended I put Signature on it.

I therefore, fervently pray that your honour would be kind enough to take action as per appropriate section of law.
