I, Smt. Somdatta Baitha (Karmakar), @ Riya Karmakar, W/O Sri Sandip Baitha, D/O Sri Buddhadeb Karmakar, now resident of C/o Sri Buddhadeb Karmakar, Surya Sikha Sarani, Hyderpara, P.O. Rabindra sarani, Dist. Jalpaiguri, Pin: 734001, do hereby lodge this FIR to the effect that on 22/7/2018, I was married to Sri Sandip Baitha, S/O Sri Raghunath Baitha, permanent resident of Lower Bhanu nagar, near Bhanu nagar Bazar, Behind Vishal Cinema Hall, P.S. Bhaktinagar, Dist. Jalpaiguri, who works in Private Company for a salary of Rs 20,000/- (Rupees Twenty Thousand Only) as per his statement before marriage. The marriage was a love marriage, and took place under Hindu rites and customs at Sevoke Kali Bari.

Since the day of entry into my matrimonial home, my husband, and in-laws kept on demanding the dowry and compelled me to withdraw money from my fixed deposit amounting to Rs.1,50,000/- (Rupees One Lakh Fifty Thousand Only) with which my husband purchased a bike. My husband and inlaws almost treated me like a slave and neither provided sufficient food nor clothes or even the bare necessities and they were always criticizing whatever I did. If I dared to protest they used abusive language and threw me out of the house on several occasions. Thereafter my husband told me that he had taken video s/ pictures of our intimate moments without my knowledge and that he would put the said videos/pictures on social media if I did not get more dowry from my parents and as such my parents had to give a steel almirah on their demand and also gave the gold ornaments worth Rs.3,00,000/- which was kept in the custody of my mother in law.

Thereafter I became pregnant and I had to be shifted to my parent's house and I delivered a boy child on 7/6/2019 who is named Ayush Baitha. When the child was 7 months old, I came back to my matrimonial house but my inlaws started torturing me physically and mentally as before and made my life miserable and wanted my parents to pay all expenses for me and the child.

Even after shifting to rented house in Hyderpara, Siliguri, my husband continued his torture and compelled me to get money from my parents by blackmailing me about the said videos /pictures and one day in March 2021, when I and my husband and son were visiting my parents for some occasion, at night, my husband came drunk and began assaulting me through out the night till early morning and thereafter threatened to kill me and my son and compelled my father to give him his mobile and debit card from which he forcefully transferred a total amount of Rs 84,000/- to his Paytm account from my parents joint account.

After some days we shifted to our matrimonial house but my inlaws did not spend money on our food or medications, I and my child were completely dependent on my parents and one day when I and my child were sick and came to my parent's house, my husband compelled my parents to give him the keys of a flat which my mother had purchased and he shifted our things to the said flat except my stridhan which was kept in the custody of my inlaws and we began staying at Vivekananda Appartments, East Vivekananda pally, Rabindra Sarani, Siliguri, Dist. Jalpaiguri.

Thereafter, every night my husband used to drink alcohol till late at night with some anti social people and he would threaten to post my said videos /pictures on social media if I objected. They often ate our dinner forcefully and I and my son had to stay

hungry . On 19/8/2021 , I broke down unable to tolerate this torture day by day and tried to stop the plundering of my house and my husband and his friends Avishek Saha and Prakash, started to beat me and my son and my husband tried to strangle me but our neighbors stopped him and his said friends ran away .When my inlaws came on my husband's call, and began to assault me and my son , somehow I called my parents but my husband caught hold of my aged father and tried to strangle him and even assaulted my mother on the instigation of my said inlaws and together they threw my aged parents out of their own flat and threatened to kill me ,my son and my parents unless my parents transferred the flat to my husband's name. When our neighbors threatened to call the police, my husband and in laws left the said flat but they tried to take away my son forcefully from me. My inlaws often threaten to kill us all over phone unless their demands were met. I had to shift to my parent's home since my husband follows me if I go out and tries to assault us .Our well wishers have made several attempts to talk but they never listen to them. My husband even contacted our family friend and well wisher Mr. Ajay Halder and abused him verbally and even threatened to kill him as he was helping us to mediate.

Again on 13/3/2022, when my father was outside the house with my child, my husband and my said inlaws suddenly came and tried to take away my two and half year old son but when my father told him that the child cannot be separated from his mother at this age my husband again tried to strangle him and threw him on the road and even slapped my little child and forcefully grabbed the child while my husband's brother in law Rahul Gupta picked up a brick and threw it at my father's head in an attempt to kill him but while they tried to escape , one of our neighbours had called police and on seeing the police van they left the child and ran away.

Sir, I am certain that my said husband had trapped me into this marriage for extortion and he and his family and friends have successfully extorted a lot of money from us and all my stridhan and personal things are still in their custody. They have now become desperate to extort us further and that they can use any means to do so . As such,I and my family including my little son are helplessly living in extreme fear ,stress and agony and I am certain that if nothing is done to stop them, we will be attacked on road or in our house by my husband ,and inlaws or their anti social friends and may even be killed by them for money.

I therefore request you to save our lives by preventing them from doing their illegal activities by immediately taking the urgently required appropriate legal action against my husband, Sri Sandip Baitha, Father in law Raghu nath Baitha, mother in law Phulmati Devi Baitha, unmarried sister in law Priya Kumari Baitha, my husband's friends Avishek saha and one Prakash, all residents of Lower Bhanu nagar, near Bhanu nagar Bazar, Behind Vishal Cinema Hall , P.S. Bhaktinagar, Dist. Jalpaiguri, and my husband's brother in law, Rahul Gupta, resident of Gate Bazar, Matigara, District Darjeeling . It may be mentioned here that I could not lodge the FIR earlier because I was in a state of shock.
